**GRANT OF SECURITY INTEREST  
PATENTS AND TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, COAST DENTAL SERVICES, INC., a Florida corporation (the "Grantor"), with principal offices at 4010 W Boy Scout Blvd, Suite 1100, Tampa, FL 33607, on this 13<sup>th</sup> day of July, 2010, hereby assigns and grants to REGIONS BANK, as Collateral Agent (the "Grantee") with principal offices at 315 Deaderick Street, Nashville, TN 37238, a security interest in (i) all of the Grantor's right, title and interest in and to the Trademarks owned by it and Trademark Licenses to which it is a party (as such capitalized terms are defined in the Security Agreement referred to below) including those set forth on Schedule A attached hereto and all reissues, continuations, extensions or renewals thereof; (ii) all of the Grantor's right, title and interest in and to the Patents owned by it and Patent Licenses to which it is a party (as such capitalized terms are defined in the Security Agreement referred to below) including those set forth on Schedule B attached hereto and all reissues, continuations, continuations-in-part, renewals and extensions thereof, in each case together with (iii) all Proceeds (as such terms are defined in the Security Agreement referred to below) of the Trademarks and Patents owned by such Grantor, (iv) the goodwill of the businesses with which the Trademarks owned by such Grantor are associated, and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks and Patents owned by such Grantor or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST (this "Grant"), is made to secure the performance and payment of all the "Secured Obligations" of the Grantor, as such term is defined in the Security Agreement by and among Grantor, the other grantors from time to time party thereto and the Grantee, dated as of July 13, 2010 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

The Grantor hereby waives notice of acceptance hereof by the Grantee.

This Grant shall be construed in accordance with and governed by the law of the State of New York (without giving effect to the conflict of law principles thereof except for Section 5-1401 and 5-1402 of the New York General Obligations Law).
