TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST dated as of July [2] 2010, from General Electric Capital Corporation, as primary co-collateral agent (in such capacity, the "Agent"), for the Lenders (as defined in the Credit Agreement dated as of July 21, 2009, as the same may be amended, restated, supplemented, or otherwise modified from time to time, the) to each of the grantors listed on Annex I hereto (each individually a "Grantor" and collectively the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Revolving Facility US Intellectual Property Security Agreement dated as of July 21, 2009, in favor of Agent (the "IP Security Agreement"), a security interest (the "Security Interest") was granted by Grantors to Agent in the Collateral (as defined in the IP Security Agreement);

WHEREAS, the IP Security Agreement was recorded against certain Trademarks in the United States Patent and Trademark Office, at Reel 4058 Frame 0355 on September 9, 2009; and

WHEREAS, the IP Security Agreement was recorded against certain Patents in the United States Patent and Trademark Office, at Reel 023209 Frame 0117 on September 9, 2009; and

WHEREAS, the IP Security Agreement was promptly submitted for recordation at the United States Copyright Office; and

WHEREAS, Agent now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the IP Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release of Security Interest, the Agent hereby states as follows:


1. Definitions. The term "Released Collateral," as used herein, shall mean all of the right, title and interest of every kind and nature as of the date hereof in the patents and patent applications referred to in Schedule A hereto, the trademark and service mark registrations and applications set forth in Schedule B hereto and all copyrights registrations and applications, and exclusive copyright license set forth in Schedule C hereto, all goodwill or licenses associated therewith and all proceeds of the foregoing.

2. Release of Security Interest. Agent hereby terminates, releases and discharges the Security Interest in the Released Collateral, and any right, title or interest of Agent in such Released Collateral shall hereby cease and become void.

3. Further Assurances. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Released Collateral contemplated hereby.
