## RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of July 30, 2010 ("Effective Date") by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., in its capacity as collateral agent ("Grantee"), in favor of MERGE HEALTHCARE INCORPORATED, a Delaware corporation, CEDARA SOFTWARE (USA) LIMITED, a Delaware corporation, AMICAS, INC., a Delaware corporation, EMAGON INC., a Delaware corporation, CAMTRONICS MEDICAL SYSTEMS, LTD., a Wisconsin corporation, ULTRAVISUAL MEDICAL SYSTEMS CORPORATION, a Delaware corporation and MERGE EMED, INC., a Delaware corporation (collectively, "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Guarantee and Collateral Agreement, dated as of April 28, 2010, made by the Grantors and the other signatories thereto in favor of Grantee (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantee holds a Lien (as such term is defined in the Security Agreement) against the intellectual property rights owned by Grantor (collectively, the "Collateral");

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement (the "Trademark Security Agreement"), among Grantor and Grantee, Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantor's right, title and interest in and to the Collateral listed on Schedule I hereto (the "Trademark");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 17, 2010 at Reel 4207, Frame 0485;

WHEREAS, Grantor has requested Grantee to release the Trademark from the Lien of the Security Agreement, has delivered to the Grantee the documents prescribed by the Security Agreement to authorize and require the release of the Trademark from the Lien of the Security Agreement, and pursuant to such authorization Grantee desires to release its Lien in the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Trademark granted pursuant to the Security Agreement and the Trademark Security Agreement is hereby terminated and released.


2. Grantee hereby assigns, transfers and conveys to Grantor, without recourse, representation or warranty, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Trademark, including without limitation the entire right, title and interest in and to the Trademark, including without limitation all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto and the goodwill of the business to which the Trademark relates.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release.
