RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS

Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of December 22, 2000, executed by Four Media Company, a Delaware corporation (now known as Four Media Company, LLC, a Delaware limited liability company) (the "Grantor"), with offices at 520 Broadway, 5th Floor, Santa Monica, CA 90404, in favor of Bank of America, N.A., with offices at 901 Main Street, 14th Floor Dallas, Texas 75202, as administrative agent (in such capacity, the "Agent") for the several banks and other financial institutions (the "Lenders") from time to time parties to the Credit Agreement, dated as of December 22, 2000 (as amended, supplemented or otherwise modified, the "Credit Agreement"), among Liberty Livewire Corporation (now known as Ascent Media Group, LLC), the Lenders, Bank of America, N.A., as issuer of certain letters of credit and as swingline lender, Banc of America Securities LLC, as lead arranger and book manager, the Administrative Agent, Salomon Smith Barney Inc., as syndication agent and The Bank of New York Company, Inc., as documentation agent, which was recorded in the United States Patent and Trademark Office on June 18, 2001, at Reel 002320, Frame 0581, pursuant to which the Grantor assigned and granted to Agent a security interest in and to all of Grantor's right, title and interest in and to certain trademarks and trademark applications, including those trademarks and trademark applications specifically listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the "Marks");

WHEREAS, Agent wishes to release, retransfer and reassign to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby releases, retransfers and reassigns to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Marks and the goodwill associated therewith.
