## U.S. TRADEMARKS RELEASE

U.S. TRADEMARKS RELEASE dated as of July 28, 2010 by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., as collateral agent (in such capacity, the "*Collateral Agent*") for the Secured Parties (as defined below).

A. Reference is made to (i) the Grant of Security Interest in Trademark and Patent Rights (the "*IP Security Agreement*"), effective as of August 14, 2009 by Brunswick Corporation, a Delaware corporation (the "*Company*"), and the subsidiaries of the Company party thereto (together with the Company, the "*Grantors*") in favor of the Collateral Agent and (ii) the Pledge and Security Agreement dated as of August 14, 2009 (together with the IP Security Agreement, the "*Security Agreements*"), by and between the Company, the subsidiaries of the Company party thereto and the Collateral Agent. Pursuant to the Security Agreements, the Grantors granted a security interest to the Collateral Agent, for the benefit of certain secured parties (the "*Secured Parties*"), in the trademarks set forth on Schedule I hereto (the "*Trademarks*"), which security interest was recorded with the United States Patent and Trademark Office at Reel/Frame 4057/0536.

B. In connection with a sale of the Trademarks and other assets, the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title and interest of the Collateral Agent and the Secured Parties in and to the Trademarks and the Grantors have certified to the Collateral Agent that all conditions precedent to such release under the Security Agreements have been complied with and that such release is authorized or permitted under the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks is hereby released and terminated; provided, however, that such release is expressly conditioned upon the consummation of the sale of the Trademarks. It is understood and agreed that if the sale of the Trademarks is not consummated then all the Collateral Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks in effect immediately prior to the date hereof shall remain in full force and effect and shall, to the extent perfected at such time, remain perfected.


