TRADEMARK SECURITY RELEASE

SECTION 2. Recordation. The Assignee authorizes and requests that the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Trademark Security Release.

SECTION 3. Governing Law. This Trademark Security Release shall be governed by, and construed in accordance with, the laws of the State of New York without regards to conflicts of laws principles.
