**WHEREAS** the Trademark Security Agreements have been recorded with the Assignment Division of the U.S. Patent and Trademark Office on November 3, 2005 at Reel 003187 and Frame 0077, December 28, 2006 at Reel 003451 and Frame 0816, July 16, 2007 at Reel 003580 and Frame 0699, September 5, 2007 at Reel 003615 and Frame 0408, September 5, 2007 at Reel 003615 and Frame 0415, November 6, 2007 at Reel 003655 and Frame 0709, March 20, 2009 at Reel 003956 and Frame 0509, August 11, 2009 at Reel 004041 and Frame 0917, May 10, 2010 at Reel 004201 and Frame 0899 and on May 10, 2010 at Reel 004201 and Frame 0912; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, re-pledges, reassigns and releases to the Pledgors any and all goodwill, rights, title and interest it has against the Trademark Collateral, without warranty or recourse.


