Re: Release of Intellectual Property Security Interests

To Whom It May Concern:

Reference is made to that certain Third Amended and Restated Revolving Credit and Term Loan Agreement dated as of the 5th day of May, 2010 by and between RBS Citizens, N.A. (the "Bank"), AccuMed Innovative Technologies, LLC ("AccuMed") and AccuMed Acquisition Corp. (the "Loan Agreement"); that certain Patent Security Agreement dated January 1, 2010, between AccuMed and the Bank (the "Patent Security Agreement"); and that certain Trademark Security Agreement dated January 1, 2010, between AccuMed and the Bank (the "Trademark Security Agreement").

The Bank has been made aware of a certain transaction between AccuMed and ResMed Limited ("ResMed") whereby AccuMed is selling to ResMed certain of its assets related to its current business of supplying products to ResMed pursuant to that certain Asset Purchase Agreement by and among AccuMed and ResMed, a copy of which has been provided to the Bank (collectively, the "Transaction"), including, among other things, the patents provided on Schedule A hereto (the "Transferred Patents") and the trademarks provided on Schedule A hereto (the "Transferred Trademarks").

In connection with the Transaction, the Bank hereby releases any and all interest it may have of record in the Transferred Patents and the Transferred Trademarks. The Bank hereby authorizes AccuMed to file this letter or one or more termination statements with the U.S. Patent and Trademark Office and such UCC-3 financing statement amendments as are required to reflect the termination of the Bank's interests in the Transferred Patents and the Transferred Trademarks as provided herein. The foregoing shall only be effective in the specific instance set forth above and for the specific purpose for which made, as expressly limited to the facts and circumstances referenced to herein and shall not operate (i) as a waiver of any other requirements of the Loan Agreement or (ii) as a waiver of any right, power, or remedy of the Bank under the Loan Agreement.
