## TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 5th day of October, 2010, given by DEUTSCHE BANK TRUST COMPANY AMERICAS, as Collateral Agent under the Security Agreement referred to below (the "Grantee") with principal offices at 60 Wall Street, New York, NY 10005 to TPC GROUP LLC, a Texas limited liability company (the "Grantor"), with principal offices at 5151 San Felipe, Suite 800, Houston, Texas 77056, as follows:

WHEREAS, in connection with that certain Term Loan Agreement, dated as of June 27, 2006, among Grantor, various lending institutions and Grantee, the Grantor has heretofore granted to the Grantee a security interest in certain U.S. trademarks, trademark registrations and trademark applications, including but not limited to those U.S. trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Trademarks") to secure the Secured Obligations (as defined in that certain Security Agreement (Term Loan), dated as of June 27, 2006, between the Grantee, the Grantor, and the other guarantors party thereto (the "Security Agreement")); and


WHEREAS, the Grantee wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve any and all Liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby releases, discharges, quitclaims and relinquishes unto the Grantor the continuing security interest in such Grantor's right, title and interest in, to the Trademarks, whether then owned or thereafter acquired or arising wherever located, including but not limited to the Trademarks set forth on Schedule A granted to grantee by the Grantor pursuant to the Security Agreement, which security interest was duly recorded on May 4, 2010, at Reel 004198, Frame 0403 in the United States Patent and Trademark Office.
