**ASSIGNMENT OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS**

THIS ASSIGNMENT OF SECURITY INTEREST (this "Assignment") dated as of August 26, 2010 is entered into by and between Deutsche Bank AG New York Branch ("DBNY") and Barclays Bank PLC ("Barclays"). WHEREAS, pursuant to the Credit Agreement, dated as of January 24, 2005 (as the same may be or may have been amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Jarden Corporation (the "Borrower"), the Lenders and L/C Issuers party thereto and DBNY, serving as the "Administrative Agent" under the Credit Agreement;

WHEREAS, the Lenders and L/C Issuers severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

Services, Inc., Laser Acquisition Corp., Lehigh Consumer Products LLC, Loew-Cornell, LLC, Marker Volki USA, Inc., Marmot Mountain, LLC, Miken Sports, LLC, Nippon Coleman, Inc., Outdoor Technologies Corporation, Penn Fishing Tackle Mfg. Co., Pure Fishing, Inc., Quoin, LLC, Rawlings Sporting Goods Company, Inc., Sea Striker, LLC, Shakespeare Company, LLC, Shakespeare Conductive Fibers, LLC, SI II, Inc., Sitca Corporation, Sunbeam Americas Holdings, LLC, Sunbeam Products, Inc., The Coleman Company, Inc. The United States Playing Card Company and USPC Holding, Inc. (collectively, the "Grantors") and DBNY, the Lenders, the L/C Issuers and other secured parties thereto (collectively, the "Secured Parties") were parties to a certain Pledge and Security Agreement, dated as of January 24, 2005, (as the same may be or may have been amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered certain Patent Security Agreements and certain Trademark Security Agreements whereby such Grantors mortgaged, pledged, and hypothecated to the administrative agent under the Security Agreement, and granted such administrative agent a security interest in certain patents and trademarks including, without limitation, those listed on Schedule A attached hereto (the "Secured IP") for the benefit of the Secured Parties;

WHEREAS, pursuant to that certain Amendment No. 10 to Credit Agreement and Amendment No. 4 to Pledge and Security Agreement, dated as of January 29, 2009 DBNY replaced Lehman Commercial Paper Inc. ("Lehman") as the Administrative Agent under the Credit Agreement and the Security Agreement;
