**TRADEMARK SECURITY AGREEMENT**

**TRADEMARK SECURITY AGREEMENT** dated as of October 8, 2010 (this "Trademark Agreement"), by and among **ICON HEALTH & FITNESS, INC.**, a Delaware corporation (the "Company"), **ICON INTERNATIONAL HOLDINGS, INC.**, a Delaware corporation ("International"), **UNIVERSAL TECHNICAL SERVICES**, a Utah corporation ("Universal"), **FREE MOTION FITNESS, INC.**, a Utah corporation ("Free Motion"), **ICON IP, INC.**, a Delaware corporation ("ICON IP"), **510152 N.B. LTD.**, a corporation organized under the laws of the province of New Brunswick ("ICON New Brunswick"), **ICON DU CANADA INC.**, a corporation organized under the laws of the province of Quebec ("ICON du Canada") and each "Additional Grantor" as described in Section 22 below (each Additional Grantor, together with the Company, International, Universal, Free Motion, ICON IP, ICON New Brunswick and ICON du Canada, collectively, the "Grantors"), and **WILMINGTON TRUST FSB**, as collateral agent (hereinafter, in such capacity, the "Collateral Agent") for itself and the Secured Parties.

**WHEREAS**, the Company and the other Grantors have entered into that certain Indenture, dated as of October 8, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Indenture"), by and among the Company, the other Grantors and Wilmington Trust FSB, as trustee (together with its successors in such capacity, the "Trustee"), on behalf of the Holders (the "Noteholders") of the Notes (as defined below) pursuant to which the Company is issuing \$205,000,000 aggregate principal amount at maturity of its 11 7/8% Senior Secured Notes due 2016 (the "Notes");

**WHEREAS**, the Trustee has been appointed to serve as Collateral Agent under the Indenture and in such capacity, is authorized and directed to enter into this Trademark Agreement;

**WHEREAS**, each Grantor will receive substantial benefits from the execution, delivery and performance of the obligations under the Indenture and the Notes and each is, therefore, willing to enter into this Trademark Agreement (which benefits are hereby acknowledged);

**WHEREAS**, in order to induce the Trustee to enter into the Indenture and to induce the Noteholders to purchase the Notes, the Grantors have agreed to execute and deliver to the Collateral Agent, for the benefit of the Collateral Agent and the other Secured Parties, a trademark security agreement in substantially the form hereof;

**WHEREAS**, each Grantor has executed and delivered to the Collateral Agent, for the benefit of the Collateral Agent and the other Secured Parties, the Security Agreement, pursuant to which the Grantor has granted to the Collateral Agent, for the benefit of the Collateral Agent and the other Secured Parties, a security interest in certain of each Grantors' personal property and fixture assets, including without limitation the trademarks, service marks, trademark and service mark registrations, and trademark and service mark registration applications listed on Exhibit A-1 attached hereto, all to secure the payment and performance of the Secured Obligations (or, in the case of ICON du Canada, its guaranty pursuant to the ICON du Canada Guaranty of the performance and payment in full in cash of all of the Secured Obligations of ICON New Brunswick); and

**WHEREAS**, this Trademark Agreement is supplemental to the provisions contained in the Security Agreement.

**NOW, THEREFORE**, in consideration of the premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

## 1. DEFINITIONS.

Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Security Agreement or Indenture. In addition, the following terms shall have the meanings set forth in this Section 1 or elsewhere in this Trademark Agreement referred to below:

Assignment of Marks. See Section 2.1.

Associated Goodwill. All goodwill of each Grantor and its business, products and services appurtenant to, associated with or symbolized by the Trademarks and the Use thereof.

Pledged Trademarks. All of each Grantor's right, title and interest in and to all of the Trademarks, the Trademark Registrations, the Trademark License Rights, the Trademark Rights, the Associated Goodwill, the Related Assets, and all accessions to, substitutions for, replacements of, and all products and proceeds of any and all of the foregoing. For the avoidance of doubt, the Pledged Trademarks shall not include any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent, if any, that, and solely during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law.

PTO. The United States Patent and Trademark Office and any successor agency.

Related Assets. All assets, rights and interests of the each Grantor that uniquely reflect or embody the Associated Goodwill, including the following:

(a) all patents, inventions, copyrights, trade secrets, confidential information, formulae, methods or processes, compounds, recipes, know-how, methods and operating systems, drawings, descriptions, formulations, manufacturing and production and delivery procedures, quality control procedures, product and service specifications, catalogs, price lists, and advertising materials, relating to the manufacture, production, delivery, provision and sale of goods or services under or in association with any of the Trademarks; and

(b) the following documents and things in the possession or under the control of such Grantor, or subject to its demand for possession or control, related to the production, delivery, provision and sale by such Grantor, or any affiliate, franchisee, licensee or contractor, of products or services sold by or under the authority of such Grantor in con-

nection with the Trademarks or Trademark Rights, whether prior to, on or subsequent to the date hereof:

(i) all lists, contracts, ancillary documents and other information that identify, describe or provide information with respect to any customers, dealers or distributors of such Grantor, its affiliates or franchisees or licensees or contractors, for products or services sold under or in connection with the Trademarks or Trademark Rights, including all lists and documents containing information regarding each customer's, dealer's or distributor's name and address, credit, payment, discount, delivery and other sale terms, and history, pattern and total of purchases by brand, product, style, size and quantity;

(ii) all agreements (including franchise agreements), product and service specification documents and operating, production and quality control manuals relating to or used in the design, manufacture, production, delivery, provision and sale of products or services under or in connection with the Trademarks or Trademark Rights;

(iii) all documents and agreements relating to the identity and locations of all sources of supply, all terms of purchase and delivery, for all materials, components, raw materials and other supplies and services used in the manufacture, production, provision, delivery and sale of products or services under or in connection with the Trademarks or Trademark Rights; and

(iv) all agreements and documents constituting or concerning the present or future, current or proposed advertising and promotion by such Grantor (or any of its affiliates, franchisees, licensees or contractors) of products or services sold under or in connection with the Trademarks or Trademark Rights.

Trademark License Rights. Any and all past, present or future rights and interests of each Grantor pursuant to any and all past, present and future franchising or licensing agreements in favor of such Grantor, or to which such Grantor is a party, pertaining to any Trademarks, Trademark Registrations, or Trademark Rights owned or used by third parties in the past, present or future, including the right (but not the obligation) in the name of such Grantor or the Collateral Agent to enforce, and sue and recover for, any breach or violation of any such agreement to which such Grantor is a party.

Trademark Registrations. All past, present or future federal, state, local and foreign registrations of the Trademarks, all past, present and future applications for any such registrations (and any such registrations thereof upon approval of such applications), together with the right (but not the obligation) to apply for such registrations (and prosecute such applications) in the name of each Grantor or the Collateral Agent, and to take any and all actions necessary or appropriate to maintain such registrations in effect and renew and extend such registrations.

Trademark Rights. Any and all past, present or future rights in, to and associated with the Trademarks throughout the world, whether arising under federal law, state law, common law, foreign law or otherwise, including the following: all such rights arising out of or associated

with the Trademark Registrations; the right (but not the obligation) to register claims under any state, federal or foreign trademark law or regulation; the right (but not the obligation) to sue or bring opposition or cancellation proceedings in the name of each Grantor or the Collateral Agent for any and all past, present and future infringements or dilution of or any other damages or injury to the Trademarks, the Trademark Rights, or the Associated Goodwill, and the rights to damages or profits due or accrued arising out of or in connection with any such past, present or future infringement, dilution, damage or injury; and the Trademark License Rights.

Trademarks. All of the trademarks, service marks, designs, logos, indicia, trade names, corporate names, company names, business names, fictitious business names, trade styles, elements of package or trade dress, and other source and product or service identifiers, used or associated with or appurtenant to the products, services and businesses of each Grantor, that (i) are set forth on Exhibit A-1 and Exhibit A-2 hereto, or (ii) have been adopted, acquired, owned, held or used by each Grantor or are now owned, held or used by each Grantor, in each Grantor 's business, or with such Grantor's products and services, or in which such Grantor has any right, title or interest, or (iii) are in the future adopted, acquired, owned, held and used by such Grantor in such Grantor's business or with the Grantor's products and services, or in which the Grantor in the future acquires any right, title or interest.

Use. With respect to any Trademark, all uses of such Trademark by, for or in connection with each Grantor or its business or for the direct or indirect benefit of such Grantor or its business, including all such uses by such Grantor itself, by any of the affiliates of such Grantor, or by any franchisee, licensee or contractor of the Grantor.

Unless otherwise provided herein, the rules of construction set forth in Section 1.04 of the Indenture shall be applicable to this Trademark Agreement.

## **2. GRANT OF SECURITY INTEREST.**

**2.1 Security Interest; Assignment of Marks.** As collateral security for the payment and performance in full of all of the Secured Obligations (or, in the case of ICON du Canada, its guaranty pursuant to the ICON du Canada Guaranty of the performance and payment in full in cash of all of the Secured Obligations of ICON New Brunswick), each Grantor hereby unconditionally grants to the Collateral Agent, for the benefit of the Collateral Agent and the other Secured Parties, a continuing security interest in and lien on the Pledged Trademarks, and pledges and mortgages (but does not transfer title to) the Pledged Trademarks to the Collateral Agent for the benefit of the Collateral Agent and the other Secured Parties. In addition, each Grantor has executed in blank and delivered to the Collateral Agent an assignment of federally registered trademarks in substantially the form of Exhibit B hereto (the "Assignment of Marks"). Each Grantor hereby authorizes the Collateral Agent to complete as assignee and record with the PTO the Assignment of Marks upon the occurrence and during the continuance of an Event of Default and the proper exercise of the Collateral Agent's remedies under this Trademark Agreement and the Security Agreement; provided the Collateral Agent shall have no obligation to complete or record such Assignment of Marks. Notwithstanding anything herein to the contrary, in no event shall the security interest granted under this Trademark Agreement attach to any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham



Act or an “Amendment to Allege Use” pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent, if any, that, and solely during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law.

**2.2 Conditional Assignment.** In addition to, and not by way of limitation of, the grant, pledge and mortgage of the Pledged Trademarks provided in Section 2.1, each Grantor grants, assigns, transfers, conveys and sets over to the Collateral Agent, for the benefit of the Collateral Agent and the other Secured Parties, such Grantor’s entire right, title and interest in and to the Pledged Trademarks; provided that such grant, assignment, transfer and conveyance shall be and become of force and effect only (i) upon or after the occurrence and during the continuance of an Event of Default and (ii) either (A) upon the written demand of the Collateral Agent at any time during such continuance or (B) immediately and automatically (without notice or action of any kind by the Collateral Agent) upon an Event of Default for which acceleration of the Notes is automatic under the Indenture or upon the sale or other disposition of or foreclosure upon the Collateral pursuant to the Security Agreement, and applicable law (including the transfer or other disposition of the Collateral by such Grantor to the Collateral Agent or its nominee in lieu of foreclosure).

**2.3 Supplemental to Security Agreement.** Pursuant to the Security Agreement, each Grantor has granted to the Collateral Agent, for the benefit of the Collateral Agent and the other Secured Parties, a continuing security interest in and lien on the Collateral (including the Pledged Trademarks). The Security Agreement, and all rights and interests of the Collateral Agent in and to the Collateral (including the Pledged Trademarks) thereunder, are hereby ratified and confirmed in all respects. In no event shall this Trademark Agreement, the grant, collateral assignment, pledge and mortgage of the Pledged Trademarks hereunder, or the recordation of this Trademark Agreement (or any document hereunder) with the PTO, adversely affect or impair, in any way or to any extent, the Security Agreement, the security interest of the Collateral Agent in the Collateral (including the Pledged Trademarks) pursuant to the Security Agreement and this Trademark Agreement, the attachment and perfection of such security interest under the Uniform Commercial Code (including the security interest in the Pledged Trademarks), or any present or future rights and interests of the Collateral Agent in and to the Collateral under or in connection with the Security Agreement, this Trademark Agreement or the Uniform Commercial Code. Any and all rights and interests of the Collateral Agent in and to the Pledged Trademarks (and any and all obligations of each Grantor with respect to the Pledged Trademarks) provided herein, or arising hereunder or in connection herewith, shall only supplement and be cumulative and in addition to the rights and interests of the Collateral Agent (and the obligations of the Grantor) in, to or with respect to the Collateral (including the Pledged Trademarks) provided in or arising under or in connection with the Security Agreement and shall not be in derogation thereof.

### **3. REPRESENTATIONS, WARRANTIES AND COVENANTS.**

Each Grantor represents, warrants and covenants that:

- (a) Exhibit A-1 sets forth a true and complete list of all Trademark Registrations now owned or controlled by such Grantor and Exhibit A-2 sets forth a true and

complete list of all material Trademark Registrations owned by entities that are not Grantors, but which are licensed, controlled or used by such Grantor;

(b) the Trademarks and Trademark Registrations are subsisting and have not been adjudged invalid or unenforceable, in whole or in part, and there is no litigation or proceeding pending concerning the validity or enforceability of the Trademarks or Trademark Registrations;

(c) to the best of such Grantor's knowledge, each of its Trademarks and Trademark Registrations is valid and enforceable;

(d) Except as set forth on Exhibit D hereto, to the best of such Grantor's knowledge, there is no infringement by others of its Trademarks, Trademark Registrations or Trademark Rights;

(e) no claim has been made that the Use of any of its Trademarks does or may violate the rights of any third person, and to the best of such Grantor's knowledge, there is no infringement by such Grantor of the trademark rights of others;

(f) such Grantor is the sole and exclusive owner of the entire and unencumbered right, title, and interest in and to each of the Trademarks (other than ownership and other rights reserved by third party owners with respect to Trademarks that each Grantor is licensed to use), free and clear of any liens, charges, encumbrances and adverse claims, including pledges, assignments, licenses, registered user agreements and covenants by such Grantor not to sue third Persons, except as set forth on Exhibit C, other than the security interest and assignment created by the Security Agreement and other than Permitted Liens;

(g) such Grantor has the unqualified right to enter into this Trademark Agreement and to perform its terms;

(h) such Grantor has used, and will continue to use, proper statutory and other appropriate proprietary notices in connection with its use of the Trademark Registrations set forth on Exhibit A-1 and Exhibit A-2;

(i) such Grantor has used, and will continue to use for the duration of this Trademark Agreement, consistent standards of quality in its manufacture and provision of products and services sold or provided under the Trademarks;

(j) this Trademark Agreement, together with the Security Agreement, will create in favor of the Collateral Agent a valid and perfected security interest in the Pledged Trademarks (other than Pledged Trademarks arising under non-U.S. law) upon making the filings referred to in clause (l) of this Section 3 prior to all Liens other than Permitted Liens;

(k) except for the filing of financing statements with the applicable Secretaries of State under the Uniform Commercial Code and the recording of this Trademark Agreement with the PTO or any similar office or agency of any foreign country, no au-

thorization, approval or other action by, and no notice to or filing with, any governmental or regulatory authority, agency or office is required either (A) for the grant by such Grantor or the effectiveness of the security interest and assignment granted hereby or for the execution, delivery and performance of this Trademark Agreement by such Grantor, or (B) for the perfection of or the exercise by the Collateral Agent of any of its rights and remedies hereunder; and

(1) such Grantor shall keep and maintain at its own cost and expense reasonably satisfactory and complete books and records of the Pledged Trademarks, and each Grantor shall permit the Collateral Agent and each other Secured Party and their respective representatives to review such books and records subject (except when an Event of Default exists) to reasonable notice and during normal business hours at the location where such books and records are kept and shall otherwise comply with Section 7.02 of the Indenture.

#### **4. INSPECTION RIGHTS.**

Each Grantor hereby grants to each of the Collateral Agent and the other Secured Parties and its employees and agents the right to visit such Grantor's plants and facilities that manufacture, inspect or store products sold under any of the Trademarks, and to inspect the products and quality control records relating thereto in accordance with the terms agreed to in the Indenture,

#### **5. NO TRANSFER OR INCONSISTENT AGREEMENTS.**

Except as permitted by the Indenture, each Grantor will not (i) mortgage, pledge, assign, encumber, grant a Lien on, transfer, dispose, sell, license or alienate any of the Pledged Trademarks, or (ii) enter into any agreement (for example, a license agreement) that is inconsistent with such Grantor's obligations under this Trademark Agreement or the Security Agreement.

#### **6. AFTER-ACQUIRED TRADEMARKS, ETC.**

**6.1 After-acquired Trademarks.** If, before the Secured Obligations shall have been finally paid and satisfied in full, any Grantor shall obtain any right, title or interest in or to any other or new Trademarks, Trademark Registrations or Trademark Rights, the provisions of this Trademark Agreement shall automatically apply thereto and such Grantor shall provide to the Collateral Agent notice thereof in writing on a quarterly basis, concurrently with the delivery of each Compliance Certificate, and in accordance with the terms agreed to in the Indenture, and file with the PTO a trademark security agreement with respect to such new Trademark Registrations substantially in the form of this Trademark Agreement, in form reasonably satisfactory to the Collateral Agent, and execute and deliver all other documents, instruments and information (including serial numbers, application numbers, application dates, registration dates) as the Collateral Agent may reasonably request further to implement, preserve or evidence the Collateral Agent's interest therein.

**6.2 Amendment to Exhibit.** Each Grantor authorizes the Collateral Agent to modify this Trademark Agreement and the Assignment of Marks, without the necessity of any Grantor's further approval or signature, by amending Exhibit A-1 and Exhibit A-2 hereto and the Annex A

to the Assignment of Marks to include any future or other Trademarks, Trademark Registrations or Trademark Rights under Section 2 or Section 6 so long as such is not inconsistent with any of such future Trademarks, Trademark Registrations or Trademark Rights that the Grantor provides notice of to the Collateral Agent.

## **7. TRADEMARK PROSECUTION.**

**7.1 Grantors Responsible.** Each Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with the Pledged Trademarks, and shall hold each of the Collateral Agent and the other Secured Parties harmless from any and all costs, damages, liabilities and expenses that may be incurred by the Collateral Agent or any other Secured Party in connection with the Collateral Agent's interest in the Pledged Trademarks or any other action or failure to act in connection with this Trademark Agreement or the transactions contemplated hereby.

**7.2 Grantor's Duties, etc.** Each Grantor shall have the right and the duty to prosecute diligently any trademark registration applications of its respective Trademarks pending as of the date of this Trademark Agreement or thereafter, to preserve and maintain all rights in its respective Trademarks and Trademark Registrations, including the filing of appropriate renewal applications and other instruments to maintain in effect the Trademark Registrations and the payment when due of all registration renewal fees and other fees, taxes and other expenses that shall be incurred or that shall accrue with respect to any of the Trademarks or Trademark Registrations. Any expenses incurred in connection with such applications and actions shall be borne by the Grantors on a joint and several basis. No Grantor shall abandon any filed trademark registration application, or any Trademark Registration or Trademark, without the consent of the Collateral Agent, which consent shall not be unreasonably withheld, unless such abandonment is made by the Grantor in its reasonable business judgment and would not have a material adverse effect on the conduct of the business of the Grantors, taken as a whole.

**7.3 Grantor's Enforcement Rights.** Each Grantor shall have the right and the duty to bring suit or other action in such Grantor's own name to maintain and enforce the Trademarks, the Trademark Registrations, the Trademark Rights, the Trademark License Rights and any other rights pertaining to the Pledged Trademarks against any third party infringing or potentially infringing any of the rights thereof. Further, each Grantor shall have the right to recover and retain all settlement proceeds, damages, royalties and consideration for past, current and future infringement by any such third party as well as retaining any royalties received from any licensing arrangements resulting therefrom. Each Grantor may require the Collateral Agent to join in such suit or action as necessary to assure such Grantor's ability to bring and maintain any such suit or action in any proper forum if (but only if) the Collateral Agent is completely satisfied that such joinder will not subject the Collateral Agent or any other Secured Party to any risk of liability. Each Grantor shall promptly, upon demand, reimburse and indemnify the Collateral Agent and the other Secured Parties for all damages, costs and expenses, including reasonable legal fees, incurred by the Collateral Agent pursuant to this Section 7.3.

**7.4 Protection of Trademarks, etc.** In general, each Grantor shall take any and all such actions (including, but not limited to institution and maintenance of suits, proceedings or actions) as, in such Grantor's reasonable business judgment, may be necessary or appropriate to

properly maintain, protect, preserve, care for and enforce all Pledged Trademarks, except as provided in Section 11.02 of the Indenture. No Grantor shall take or fail to take any action, nor permit any action to be taken or not taken by others under its control, that would adversely affect the validity, grant or enforcement of the Pledged Trademarks, except where the failure to take or not take such action or permit such action to be taken or not taken by others would not reasonably be expected to have a material adverse effect on the conduct of the business of the Grantors, taken as a whole.

**7.5 Notification by Grantor.** On a quarterly basis, concurrently with the delivery of each Compliance Certificate, each Grantor will notify the Collateral Agent in writing of the institution of, or any final adverse determination in, any proceeding in the PTO or any similar office or agency of the United States or any foreign country, or any court, regarding the validity of any of the Trademarks or Trademark Registrations or such Grantor's rights, title or interests in and to the Pledged Trademarks, and of any event that does or reasonably could materially adversely affect the value of any of the Pledged Trademarks, the ability of any Grantor or the Collateral Agent to dispose of any of the Pledged Trademarks or the rights and remedies of the Collateral Agent in relation thereto (including but not limited to the levy of any legal process against any of the Pledged Trademarks).

## **8. REMEDIES.**

Upon the occurrence and during the continuance of an Event of Default, in addition to all other rights and remedies given it by this Trademark Agreement (including, without limitation, those set forth in Section 2.2, the Indenture, the Security Agreement and the other Security Documents, those allowed by law and the rights and remedies of a secured party under the Uniform Commercial Code, and, without limiting the generality of the foregoing, the Collateral Agent may immediately, without demand of performance and without other notice (except as set forth next below) or demand whatsoever to any Grantor, all of which are hereby expressly waived, and without advertisement, sell or license at public or private sale or otherwise realize upon the whole or from time to time any part of the Pledged Trademarks, or any interest that any Grantor may have therein, and after deducting from the proceeds of sale or other disposition of the Pledged Trademarks all expenses incurred by the Collateral Agent in attempting to enforce this Trademark Agreement (including all reasonable expenses for broker's fees and legal services), shall apply the residue of such proceeds toward the payment of the Secured Obligations as set forth in the Security Agreement. Notice of any sale, license or other disposition of the Pledged Trademarks shall be given to the Grantors at least ten (10) days before the time that any intended public sale or other public disposition of the Pledged Trademarks is to be made or after which any private sale or other private disposition of the Pledged Trademarks may be made, which the Grantors hereby agree shall be reasonable notice of such public or private sale or other disposition. At any such sale or other disposition, the Collateral Agent may, to the extent permitted under applicable law, purchase or license the whole or any part of the Pledged Trademarks or interests therein sold, licensed or otherwise disposed of.

## **9. COLLATERAL PROTECTION.**

If any Grantor shall fail to do any act that it has covenanted to do hereunder, or if any representation or warranty of any Grantor shall be breached, the Collateral Agent, in its own

name or that of such Grantor (in the sole discretion of the Collateral Agent), may (but shall not be obligated to) do such act or remedy such breach (or cause such act to be done or such breach to be remedied), and such Grantor agrees promptly to reimburse the Collateral Agent for any cost or expense incurred by the Collateral Agent in so doing.

#### **10. POWER OF ATTORNEY.**

If any Event of Default shall have occurred and be continuing, each Grantor does hereby make, constitute and appoint the Collateral Agent (and any officer or agent of the Collateral Agent as the Collateral Agent may select in its exclusive discretion) as such Grantor's true and lawful attorney-in-fact, with full power of substitution and with the power to endorse such Grantor's name on all applications, documents, papers and instruments necessary for the Collateral Agent to use the Pledged Trademarks, or to grant or issue any exclusive or nonexclusive license of any of the Pledged Trademarks to any third person, or to take any and all actions necessary for the Collateral Agent to assign, pledge, convey or otherwise transfer title in or dispose of any of the Pledged Trademarks or any interest of such Grantor therein to any third person, and, in general, to execute and deliver any instruments or documents and do all other acts that such Grantor is obligated to execute and do hereunder. Each Grantor hereby ratifies all that such attorney shall lawfully do or cause to be done by virtue hereof and releases each of the Collateral Agent and the other Secured Parties from any claims, liabilities, causes of action or demands arising out of or in connection with any action taken or omitted to be taken by the Collateral Agent under this power of attorney (except for the Collateral Agent's gross negligence or willful misconduct). This power of attorney is coupled with an interest and shall be irrevocable for the duration of this Trademark Agreement.

#### **11. FURTHER ASSURANCES.**

Each Grantor shall, at any time and from time to time, and at its expense, make, execute, acknowledge and deliver, and file and record as necessary or appropriate with governmental or regulatory authorities, agencies or offices, such agreements, assignments, documents and instruments, and do such other and further acts and things (including, without limitation, obtaining consents of third parties), as the Collateral Agent may reasonably request or as may be necessary or appropriate in order to implement and effect fully the intentions, purposes and provisions of this Trademark Agreement, or to assure and confirm to the Collateral Agent the grant, perfection and priority of the Collateral Agent's security interest in the Pledged Trademarks.

#### **12. TERMINATION.**

At such time as all of the Secured Obligations have been finally paid and satisfied in full in cash and the cancellation and termination of all other obligations of the Secured Parties under the Security Documents and with respect to the Secured Obligations, this Trademark Agreement shall terminate and the Collateral Agent shall, upon the written request and at the expense of the Grantors on a joint and several basis, take reasonable actions to execute and deliver to such Grantor all deeds, assignments and other instruments as may be necessary or proper to release the security interest in and to the Pledged Trademarks previously granted, assigned, transferred and conveyed to the Collateral Agent by such Grantor pursuant to this Trademark Agreement, as fully as if this Trademark Agreement had not been made, subject to any disposition of all or any

part thereof that may have been made by the Collateral Agent pursuant hereto or the Security Agreement.

**13. COURSE OF DEALING.**

No course of dealing between any Grantor and the Collateral Agent, nor any failure to exercise, nor any delay in exercising, on the part of the Collateral Agent, any right, power or privilege hereunder or under the Security Agreement or any other agreement shall operate as a waiver thereof; nor shall any single or partial exercise of any right, power or privilege hereunder or thereunder preclude any other or further exercise thereof or the exercise of any other right, power or privilege.

**14. EXPENSES.**

Any and all fees, costs and expenses, of whatever kind or nature, including the reasonable attorneys' fees and expenses incurred by the Collateral Agent in connection with the preparation of this Trademark Agreement and all other documents relating hereto, the consummation of the transactions contemplated hereby or the enforcement hereof, the filing or recording of any documents (including all taxes in connection therewith) in public offices, the payment or discharge of any taxes, counsel fees, maintenance or renewal fees, encumbrances, or otherwise protecting, maintaining or preserving the Pledged Trademarks, or in defending or prosecuting any actions or proceedings arising out of or related to the Pledged Trademarks, shall be borne and paid by the Grantors on a joint and several basis.

**15. OVERDUE AMOUNTS.**

Until paid, all amounts due and payable by the Grantors hereunder shall be a debt secured by the Pledged Trademarks and other Collateral and shall bear, whether before or after judgment, interest at the Default Rate in accordance with the Indenture.

**16. NO ASSUMPTION OF LIABILITY; INDEMNIFICATION.**

NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED HEREIN, NEITHER THE COLLATERAL AGENT NOR ANY OTHER SECURED PARTY ASSUMES ANY LIABILITIES OF THE GRANTORS WITH RESPECT TO ANY CLAIM OR CLAIMS REGARDING ANY GRANTOR'S OWNERSHIP OR PURPORTED OWNERSHIP OF, OR RIGHTS OR PURPORTED RIGHTS ARISING FROM, ANY OF THE PLEDGED TRADEMARKS OR ANY USE, LICENSE OR SUBLICENSE THEREOF, WHETHER ARISING OUT OF ANY PAST, CURRENT OR FUTURE EVENT, CIRCUMSTANCE, ACT OR OMISSION OR OTHERWISE. ALL OF SUCH LIABILITIES SHALL BE BORNE BY THE GRANTORS ON A JOINT AND SEVERAL BASIS. THE GRANTORS SHALL JOINTLY AND SEVERALLY INDEMNIFY THE COLLATERAL AGENT AND THE OTHER SECURED PARTIES FOR ANY AND ALL COSTS, EXPENSES, DAMAGES AND CLAIMS, INCLUDING REASONABLE LEGAL FEES, INCURRED BY THE COLLATERAL AGENT OR ANY OTHER SECURED PARTY WITH RESPECT TO SUCH LIABILITIES.

**17. NOTICES.**

All notices and other communications made or required to be given pursuant to this Trademark Agreement shall be delivered in writing as set forth in Section 15.02 of the Indenture.

**18. AMENDMENT AND WAIVER.**

This Trademark Agreement is subject to modification only by a writing signed by the Collateral Agent and the Grantors, except as provided in Section 6.2. The Collateral Agent shall not be deemed to have waived any right hereunder unless such waiver shall be in writing and signed by the Collateral Agent. A waiver on any one occasion shall not be construed as a bar to or waiver of any right on any future occasion.

**19. GOVERNING LAW; CONSENT TO JURISDICTION.**

THIS TRADEMARK AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK (EXCLUDING THE LAWS APPLICABLE TO CONFLICTS OR CHOICE OF LAW (OTHER THAN THE NEW YORK GENERAL OBLIGATIONS LAW §5-1401)). EACH GRANTOR IRREVOCABLY AND UNCONDITIONALLY SUBMITS, FOR ITSELF AND ITS PROPERTY, TO THE NONEXCLUSIVE JURISDICTION OF THE COURTS OF THE STATE OF NEW YORK SITTING IN NEW YORK COUNTY AND OF THE UNITED STATES DISTRICT COURT OF THE SOUTHERN DISTRICT OF NEW YORK, AND ANY APPELLATE COURT FROM ANY THEREOF, IN ANY ACTION OR PROCEEDING ARISING OUT OF OR RELATING TO THIS TRADEMARK AGREEMENT OR ANY OTHER SECURITY DOCUMENT, OR FOR RECOGNITION OR ENFORCEMENT OF ANY JUDGMENT, AND EACH GRANTOR IRREVOCABLY AND UNCONDITIONALLY AGREES THAT ALL CLAIMS IN RESPECT OF ANY SUCH ACTION OR PROCEEDING MAY BE HEARD AND DETERMINED IN SUCH NEW YORK STATE COURT OR, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN SUCH FEDERAL COURT. EACH GRANTOR HERETO AGREES THAT A FINAL JUDGMENT IN ANY SUCH ACTION OR PROCEEDING SHALL BE CONCLUSIVE AND MAY BE ENFORCED IN OTHER JURISDICTIONS BY SUIT ON THE JUDGMENT OR IN ANY OTHER MANNER PROVIDED BY LAW. NOTHING IN THIS TRADEMARK AGREEMENT OR IN ANY OTHER SECURITY DOCUMENT SHALL AFFECT ANY RIGHT THAT ANY SECURED PARTY MAY OTHERWISE HAVE TO BRING ANY ACTION OR PROCEEDING RELATING TO THIS TRADEMARK AGREEMENT OR ANY OTHER SECURITY DOCUMENT AGAINST ANY GRANTOR OR ITS PROPERTIES IN THE COURTS OF ANY JURISDICTION.

**20. WAIVER OF JURY TRIAL.**

EACH GRANTOR HEREBY IRREVOCABLY WAIVES, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN ANY LEGAL PROCEEDING DIRECTLY OR INDIRECTLY ARISING OUT OF OR RELATING TO THIS TRADEMARK AGREEMENT OR ANY OTHER SECURITY DOCUMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY OR THEREBY



(WHETHER BASED ON CONTRACT, TORT OR ANY OTHER THEORY). EACH GRANTOR (A) CERTIFIES THAT NO REPRESENTATIVE, AGENT OR ATTORNEY OF ANY OTHER PERSON HAS REPRESENTED, EXPRESSLY OR OTHERWISE, THAT SUCH OTHER PERSON WOULD NOT, IN THE EVENT OF LITIGATION, SEEK TO ENFORCE THE FOREGOING WAIVER AND (B) ACKNOWLEDGES THAT IT HAS BEEN INDUCED TO ENTER INTO THIS TRADEMARK AGREEMENT AND THE OTHER SECURITY DOCUMENTS BY, AMONG OTHER THINGS, THE MUTUAL WAIVERS AND CERTIFICATIONS IN THIS SECTION. Except as prohibited by law, each Grantor hereby waives any right which it may have to claim or recover in any litigation referred to in the preceding sentence any special, exemplary, punitive or consequential damages or any damages other than, or in addition to, actual damages.

## **21. MISCELLANEOUS.**

The headings of each section of this Trademark Agreement are for convenience only and shall not define or limit the provisions thereof. This Trademark Agreement and all rights and obligations hereunder shall be binding upon each Grantor and its respective successors and assigns, and shall inure to the benefit of the Collateral Agent, the other Secured Parties and their respective successors and assigns. In the event of any irreconcilable conflict between the provisions of this Trademark Agreement and the Indenture, or between this Trademark Agreement and the Security Agreement, the provisions of the Indenture or the Security Agreement, as the case may be, shall control. If any term of this Trademark Agreement shall be held to be invalid, illegal or unenforceable, the validity of all other terms hereof shall in no way be affected thereby, and this Trademark Agreement shall be construed and be enforceable as if such invalid, illegal or unenforceable term had not been included herein. The Grantor acknowledges receipt of a copy of this Trademark Agreement.

## **22. ADDITIONAL GRANTORS.**

Subsidiaries of the Grantors or other Persons (each such Person, an “Additional Grantor”) may hereafter become parties to this Trademark Agreement by executing a counterpart hereof or a joinder agreement, in each case in form and substance satisfactory to the Collateral Agent, and there shall be no need to re-execute, amend or restate this Trademark Agreement in connection therewith. Upon such execution and delivery by any Additional Grantor, such Additional Grantor shall be deemed to have made the representations and warranties set forth herein, and shall be bound by all of the terms, covenants and conditions hereof to the same extent as if such Additional Grantor had executed this Trademark Agreement as of the Closing Date, and the Collateral Agent shall be entitled to all of the benefits of such Additional Grantor’s obligations hereunder.

## **23. INTERCREDITOR AGREEMENT.**

Reference is made to the Intercreditor Agreement. Notwithstanding any other provision contained herein, this Trademark Agreement, the Liens created hereby and the rights, remedies, duties and obligations provided for herein are subject in all respects to the provisions of the Intercreditor Agreement and, to the extent provided therein, the applicable Senior Secured Obligations Security Documents (as defined in the Intercreditor Agreement). In the event of any con-

flict or inconsistency between the provisions of this Trademark Agreement and the Intercreditor Agreement, the provisions of the Intercreditor Agreement shall control.

#### **24. COLLATERAL AGENT.**

The Collateral Agent shall be entitled to all of the same rights, protections, immunities and indemnities set forth in the Indenture as if specifically set forth herein.

Under no circumstances shall the Collateral Agent be deemed to assume any responsibility for or obligation or duty with respect to any part or all of the Collateral of any nature or kind or any matter or proceedings arising out of or relating thereto, other than (a) to exercise reasonable care in the physical custody of the Collateral and (b) after an Event of Default shall have occurred and be continuing to act in a commercially reasonable manner. Neither the Collateral Agent nor any other Secured Party shall be required to take any action of any kind to collect, preserve or protect its or any Grantor's rights in the Collateral or against other parties thereto. The Collateral Agent's prior recourse to any part or all of the Collateral shall not constitute a condition of any demand, suit or proceeding for payment or collection of any of the Secured Obligations.


The permissive right of the Collateral Agent to take or refrain from taking any actions enumerated in this Trademark Agreement or any other Security Document shall not be construed as a duty. The Collateral Agent shall not be obligated to request any Person to take or refrain from taking any action pursuant to this Trademark Agreement unless it shall be instructed to make such request by the Trustee acting pursuant to the instructions of the Holders of a majority in principal amount of the then total outstanding Notes.

The powers conferred on the Collateral Agent hereunder are solely to protect the interests of the Collateral Agent and the other Secured Parties in the Collateral and shall not impose any duty upon the Collateral Agent to exercise any such powers. The Collateral Agent shall be accountable only for the amounts that it actually receives as a result of the exercise of such powers, and neither it nor any of its officers, directors, employees or agents shall be responsible to any Grantor for any act or failure to act, except for the Collateral Agent's own gross negligence or willful misconduct.



## **Exhibit D**

Grantor sent a cease and desist letter, dated August 5, 2010, to Apple, Inc. ("Apple") in which Grantor asserted potential trademark infringement of Grantor's U.S. Trademark No. 2,618,509 (I FIT) by Wizag LLC and Super Art Software, two entities marketing products in Apple's iTunes App Store. Grantor is awaiting a response from Apple.

Grantor sent a cease and desist letter, dated February 18, 2010, to Landice, Inc. ("Landice") in which Grantor asserted potential patent and trademark infringement by Landice with respect to Grantor's U.S. Patent No. 5,149,084 and U.S. Trademark Nos. 2,070,489 (CARDIO TRAINER) and 3,262,982 (QUICK SPEED). Grantor offered to settle the matter by granting a nonexclusive license to Landice for Landice's past, present and future use of the patent and trademarks above in exchange for a lump-sum payment from Landice to Grantor of \$250,000. The matter is currently pending resolution between the Grantor and Landice.

Grantor is aware of a potential infringement by FreeLife Fitness, a Chinese manufacturer of fitness products that are identical to certain products in Grantor's Freemotion line.

Grantor has claims pending against Specialized Bicycle Components, Inc. for trademark and intellectual property infringement involving the "EPIC" and "EPIC Strength" trademarks.
