FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

This FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (this "Amendment") dated as of October 27, 2010 is delivered pursuant to that certain Trademark Security Agreement dated as of June 20, 2008 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Agreement"), among SPORT CHALET, INC., a Delaware corporation ("Grantor"), and BANK OF AMERICA, N.A., as administrative agent for the Lenders ("Agent") in connection with the Loan Agreement described below, recorded on June 25, 2008 as Reel/Frame 003802/0568 with the U.S. Trademark Office.

RECITALS:

WHEREAS, Grantor is indebted to Agent and the Lenders pursuant to that certain Loan and Security Agreement dated as of June 20, 2008 (as amended, restated, or otherwise modified from time to time, the "Loan Agreement"); and

WHEREAS, Grantor has provided Agent with notice that Grantor has obtained additional Trademarks;

WHEREAS, pursuant to Section 2.4 of the Trademark Agreement, Grantor has authorized Agent to unilaterally amend the scheduled information with respect to additional Trademarks.


Schedule I of the Trademark Agreement is hereby as the date hereof amended and restated in its entirety as set forth on the schedules attached hereto; provided, that no such amendment or restatement shall release or be deemed to release any security interest in any present or future Trademark granted to Agent and the Lenders as collateral pursuant to the Trademark Agreement.
