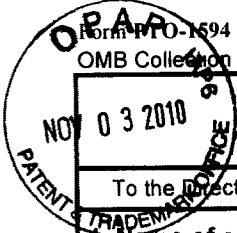

GRANT OF SECURITY INTEREST
