RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 16, 2010 (this "Release"), is made by JPMORGAN CHASE BANK, N.A., a national banking association as Collateral Agent under that certain Security Agreement (defined below), located at 1111 Fannin Street – Floor 10, Houston, Texas 77002 (the "Assignor"), in favor of INTERLINE BRANDS, INC., a Delaware corporation, located at 701 San Marco Boulevard, Jacksonville, FL 32207 and INTERLINE BRANDS, INC., a New Jersey corporation located at 701 San Marco Boulevard, Jacksonville, FL 32207 (the "Assignees"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Assignees and the Assignor, among other parties, are parties to that certain (i) Credit Agreement, dated as of June 23, 2006 (as amended, supplemented or otherwise modified, the "Credit Agreement"), (ii) Guarantee and Collateral Agreement, dated as of June 23, 2006, (as amended, supplemented or otherwise modified, the "Security Agreement") and (iii) Trademark Security Agreement, dated as of June 23, 2006 (the "Interline Trademark Security Agreement");

WHEREAS, Amsan, LLC ("Amsan") and the Assignor are parties to that certain Trademark Security Agreement, dated July 3, 2006 (the "Amsan Trademark Security Agreement");

WHEREAS, as security for the payment or performance, as the case may be, in full of the Obligations, Assignees and Amsan, pursuant to the Security Agreement and the Interline Trademark Security Agreement or the Amsan Security Agreement, as applicable, granted to the Assignor, its successors and assigns, for the benefit of the Secured Parties, a security interest in, all right, title or interest in or to any and all of the following assets and properties then owned or thereafter acquired by the Assignees or in which the Assignees then had or at any time thereafter acquired any right, title or interest (collectively, the "Trademark Collateral");

- (a) all trademarks, service marks, trade, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registrations and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State if the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I of the Interline Trademark Security Agreement or the Amsan Security Agreement, as applicable (the "Trademarks");
- (b) all goodwill associated with or symbolized by the Trademarks; and

(c) all assets, rights and interests that uniquely reflect or embody the Trademarks;

provided, however, that the foregoing grant of security interest did not include any "intent-to-use" based application for a Trademark until such time that a statement of use had been filed with the United States Patent and Trademark Office for such application;

WHEREAS, Amsan assigned its entire interest in certain then-subsisting trademarks to Interline Brands, Inc., a New Jersey corporation, which such assignment was recorded with the United States Patent and Trademark Office on February 22, 2008 at Reel/Frame No. 3722/0962;

WHEREAS, on or about December 26, 2008, Amsan merged into Interline Brands, Inc., a New Jersey corporation;

WHEREAS, Eagle Maintenance Supply, Inc. ("Eagle Maintenance") and the Assignor are parties to that certain Grant of Security Interest in United States Trademark, dated September 24, 2009 (the "Eagle Maintenance Trademark Security Agreement"), pursuant to which Eagle Maintenance granted to the Assignor a security interest in (i) all of Eagle Maintenance's rights, title and interest in and to the United States trademark, including all appurtenant good will of such trademark set for on Schedule A thereto, (ii) all Proceeds and products of such trademark and (iii) all other rights and interest that uniquely affect such goodwill, to secure the satisfactory performance and payment of all the obligations of Eagle Maintenance in the Security Agreement;

WHEREAS, the Interline Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 13, 2006 at Reel/Frame No. 3346/0872, the Amsan Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 13, 2006 at Reel/Frame No. 3347/0134 and the Eagle Maintenance Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 24, 2009 at Reel/Frame No. 4067/0864;

WHEREAS, on or about December 25, 2009, Eagle Maintenance merged into Interline Brands, Inc., a New Jersey corporation; and

WHEREAS, the Assignor and the Assignees desire that the Assignor terminate and release its security interest in, all right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademarks set forth in Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse, its security interest in, all right, title and interest in or to the Trademark Collateral, including but not limited to the Trademarks on Schedule A hereto, and reassigns and transfers any right, title and interest that the Assignor may have in the Trademark Collateral to the Assignees.

The Assignor hereby authorizes the Assignees or the Assignees' authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Assignor in the Trademark Collateral, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Assignor further agrees to execute and deliver to the Assignees any and all further documents and instruments, and do any and all further acts which the Assignees (or their agents or designees) reasonably request (at the Assignees' sole cost and expense) in order to confirm this Release and the Assignee's right, title, and interest in or to the Trademark Collateral.
