

GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, ROOFING SUPPLY GROUP, LLC, a Delaware limited liability company (the "Grantor") with principal offices at 3890 W. 


