INTELLECTUAL PROPERTY ASSIGNMENT

NOW, THEREFORE, for One Dollar and other good and valuable consideration paid by Assignee to Assignors, the receipt and sufficiency of which are hereby acknowledged, Assignors do hereby sell, assign, transfer, convey and deliver to Assignee, its successors and assigns, whatever right title and interest, in and to the Toy Mold IP that Assignors may have, if any, including but not limited to any patent rights, copyrights, trademarks, trade dress or trade secret rights embodied therein or associated therewith, which may include those rights and interests individually identified in Exhibit B hereto, to be held and enjoyed by Assignee for its own use and for the use of its successors, assigns or other legal representatives, together with all claims for damages by reason of past, present and future infringement of the rights assigned under this Intellectual Property Assignment, with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this transfer to Assignee had not been made. This Assignment includes the Trademark Registration, U.S. Registration No. 3403059 for the mark "WEE-BOOS" and any and all common law rights held by Assignors, if any, as identified in Exhibit C hereto. To the extent that any trademark and/or trade dress rights are conveyed via this Intellectual Property Assignment, Assignors expressly convey any goodwill associated with those trademark/trade dress rights to Assignee through this Assignment; and

FURTHER, each Assignor represents and warrants for himself/itself that, to the best of his/its knowledge, no other person or entity has any rights or interest in or to the toy molds, models and forms identified in Exhibit A hereto. Assignors expressly do not warrant title to or the validity of any intellectual property covered by this Assignment.

This instrument shall inure to the benefit of Assignee and its successors and assigns and shall be binding on the Assignors and their successors and assigns, effective immediately upon execution by the Assignors.
