RELEASE OF INTELLECTUAL PROPERTY COLLATERAL

THIS RELEASE OF INTELLECTUAL PROPERTY COLLATERAL (this "Release") is made as of November 30, 2010, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent (in such capacity as the "Collateral Agent") and the secured party under the Second Lien IP Security Agreement referred to below.

W I T N E S S E T H:

WHEREAS, Sirius Computer Solutions, Inc., SCS Holdings I Inc., SCS Holdings II Inc. and Sirius Enterprise Systems Group, LLC (collectively, the "Grantors"), executed that certain Intellectual Property Security Agreement, dated as of November 30, 2006 (the "Second Lien IP Security Agreement"), pursuant to which Grantors granted a security interest to the Collateral Agent in certain trademarks and other intellectual property of Grantors; and

WHEREAS, the Second Lien IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 003441, Frame 0219 on December 8, 2006; and

WHEREAS, the Collateral Agent has agreed to release all its liens on the trademarks and trademark applications of Grantors identified on Exhibit A attached hereto and all copyrights owned by the Grantors, each granted pursuant to the Second Lien IP Security Agreement and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral granted pursuant to the Second Lien IP Security Agreement to the Grantors.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases all its rights in and to the Released Collateral granted pursuant to the Second Lien IP Security Agreement, reconveys to the persons legally entitled thereto all of the Collateral Agent's right, title and interest in and to the Released Collateral granted pursuant to the Second Lien IP Security Agreement, all without warranty or representation of any kind.

This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
