**PARTIAL RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Partial Release") is made as of December 3<sup>rd</sup>, 2010 by BANK OF AMERICA, N.A., as Collateral Agent, with offices at 100 Federal Street, 9th Floor, Boston, MA 02110 (the "Agent") to and in favor of each of the entities listed on Schedule I attached hereto (each a "Debtor" and collectively the "Debtors"), in consideration of the mutual covenants herein contained and benefits to be derived herefrom.

WHEREAS, the Debtors executed and delivered that certain Intellectual Property Security Agreement dated as of October 4, 2005 (as supplemented or otherwise modified through the date hereof, the "Agreement") in favor of the Agent, pursuant to which the Debtors pledged, assigned and granted a security interest to and in favor of the Agent in certain IP Collateral, as recorded: (i) with respect to Trademarks, at the United States Patent and Trademark Office on October 18, 2005 at Reel 3208 and Frame 0224; (ii) with respect to Patents, at the United States Patent and Trademark Office on October 18, 2005, at Reel 016902 and Frame 0157 and (iii) with respect to Copyrights, with the U.S. Copyright Office on October 20, 2005 at Document V3531D217-219 P1-45. Capitalized terms used but not otherwise defined herein shall have the meanings assigned them in the Agreement.

WHEREAS, in connection with the proposed sale of certain of Debtors' assets, the Debtors have requested that the Agent release the Security Interest granted to the Agent by the Debtors with respect to Debtors' right, title and interest in and to the Trademarks, Trademark Applications and Domain Names identified on Schedule II attached hereto and incorporated herein by reference (the "Released Collateral"), to the extent of the Debtors' interest therein.

NOW, THEREFORE, it is hereby agreed as follows:

1. Release of Specified Collateral. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby:

(a) terminates and releases the liens (including the Security Interest) granted by the Debtor to the Agent pursuant to any security agreement (including, but not limited to, the Agreement) in all of Debtors' right title and interest in and to the Released Collateral; and

(b) to the extent Agent shall be deemed to have any right, title or interest in or to the Released Collateral, the Agent hereby transfers and assigns to the Debtors all of such right, title and interest solely with respect to the Released Collateral.

2. Miscellaneous.

(a) The Agent agrees that it shall, from time to time, execute, acknowledge and deliver to the Debtors and their designees, successors or assigns, at the sole cost and expense of the Debtors, such additional instruments, agreements and other documents as


such Debtor or its successors or assigns shall reasonably request in order to further evidence the release and discharge described herein.

(b) Except as provided herein, all terms and conditions of the Agreement remain in full force and effect.
