**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE (this "Release"), dated as of May 3, 2010, is made by Credit Suisse AG, Cayman Islands Branch (formerly known as Credit Suisse, Cayman Islands Branch), as Collateral Agent (the "Collateral Agent") for the banks and other financial institutions or entities (the "Lenders"), pursuant to the termination of the Credit Agreement, dated as of February 22, 2006 by and among Babcock & Wilcox Power Generation Group, Inc. (formerly known as The Babcock & Wilcox Company), a Delaware corporation (the "Borrower"), the Lenders, the Syndication Agent party thereto, the Co-Documentation Agents party thereto and the Collateral Agent, and the other Secured Parties (as from time to time amended, restated, supplemented or otherwise modified and in effect from time to time, the "Credit Agreement"). Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Credit Agreement.

WITNESSETH

WHEREAS, pursuant to the Credit Agreement, the Grantors (as defined in the Pledge and Security Agreement referred to below) executed the Pledge and Security Agreement by and among the Grantors and the Collateral Agent for the Secured Parties, dated February 22, 2006, pursuant to which the Grantors granted to the Collateral Agent a security interest in all Patent Collateral, Trademark Collateral, and Copyright Collateral (each as defined below);

WHEREAS, in connection with the Borrower's satisfaction of all of its obligations under the Credit Agreement, the Pledge and Security Agreement and the Intellectual Property Security Agreement (as amended, supplemented, or otherwise modified from time to time prior to the date hereof) have been terminated.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby agrees as follows:

1. **Definitions**

a. "**Copyright Collateral**" shall mean all of each Grantor's right, title and interest in and to (i) all copyrights arising under the laws of the United States, any other country, or union of countries, or any political subdivision of any of the foregoing, whether registered or unregistered and whether published or unpublished (including those listed on Schedule I attached hereto) all registrations and recordings thereof, and all applications in connection therewith and rights corresponding thereto throughout the world, including all registrations, recordings and applications in the United States Copyright Office, and all Mask Works (as defined in 17 USC 901), (ii) the right to, and to obtain, all extensions and renewals thereof, and the right to sue for past, present and future infringements of any of the foregoing, (iii) all proceeds of the foregoing, including license, royalties, income, payments, claims, damages, and proceeds of suit and (iv) all other rights of any kind whatsoever accruing thereunder or pertaining thereto.

b. "**Patent Collateral**" shall mean all of each Grantor's right, title and interest in and to (i) all United States patents, patents issued by any other country, union of countries or any political subdivision of any of the foregoing, and all reissues and extensions thereof, including any of the foregoing listed on Schedule I attached hereto, (ii) all patent applications pending in the United States or any other country or union of countries or any political subdivision of any of the foregoing and all divisions, continuations and continuations-in-part thereof, including any of the foregoing listed on Schedule I attached hereto, (iii) all rights to, and to obtain, any reissues or extensions of the foregoing and (iv) all proceeds of the foregoing, including licenses, royalties, income, payments, claims, damages and proceeds of suit.

c. "**Trademark Collateral**" shall mean all of each Grantor's right, title and interest in and to (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, designs and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in

2. Release of Security Interest

The Collateral Agent hereby releases, transfers and assigns, without recourse, unto each Grantor, all of its security interest and lien on all of such Grantor's right, title and interest in, to and under the Patent Collateral, Trademark Collateral, and the Copyright Collateral, including all of the foregoing listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral").

3. Recordation
