**GRANT OF SECURITY INTEREST (TRADEMARKS)**

The undersigned, **CSC SUGAR, LLC**, a Delaware limited liability company (the "Grantor") is a party to the Amended and Restated Credit Agreement, dated as of December 15, 2010 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among the Grantor, the lenders from time to time parties thereto (including, without limitation, the swing line lender and issuing lenders thereunder, the "Lenders"), BNP Paribas Securities Corp., as lead arranger and sole bookrunner, and **BNP PARIBAS**, as Administrative Agent and Collateral Agent (together with its successors and assigns in such capacity, the "Secured Party"), pursuant to which the Grantor has entered into the Amended and Restated Security Agreement, dated as of December 15, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), by and between the Grantor and the Secured Party.

Pursuant to the Security Agreement, the Grantor has granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule 1, which trademarks are registered, or have applications for registration pending, in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the prompt payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Grantor does hereby further grant to the Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Collateral made and granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


