**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of December 23, 2010, is made by JPMORGAN CHASE BANK, N.A. as collateral agent (in such capacity, the "Collateral Agent"). Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Amended and Restated Guarantee and Collateral Agreement, dated as of May 11, 2005 (the "Collateral Agreement") among AFC Enterprises, Inc., a Minnesota corporation (the "Borrower"), certain subsidiaries of the Borrower and the Collateral Agent,

WHEREAS, pursuant to that certain Second Amended and Restated Credit Agreement, dated as of May 11, 2005 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among the Borrower, the lenders and agents party thereto, and JPMorgan Chase Bank, as administrative agent (in such capacity, the "Administrative Agent") and the Collateral Agreement, recorded with the U.S. Patent and Trademark Office on May 17, 2005 at Reel/Frame No. 003086/0182, the Borrower granted Collateral Agent a security interest in its patents, patent applications and patent rights in United States patents and applications; state and federal trademarks; all common law and other rights in and to the trademarks in the United States or any state thereof; all goodwill symbolized by the trademarks; copyright registrations, copyright applications and copyright rights; and all rights and interests pursuant to licenses or other contracts in favor of Borrower pertaining to any patents, trademarks, trademark registrations or trademark rights, copyrights;

WHEREAS, the Borrower has requested that the Collateral Agent release its security interest in the Patents, Trademarks, and Copyrights, as defined in the Collateral Agreement (the "Released Collateral").

NOW, THEREFORE, subject to the provisions of this Release, effective upon the payment in full of the obligations, the Collateral Agent hereby RELEASES, without recourse, all of its security interest in the Patents, the Trademarks, and the Copyrights, listed on Schedule A attached hereto and incorporated herein by reference.

The Collateral Agent agrees to provide the Borrower with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.




