

GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, TRANSOLUTIONS, INC., a Delaware corporation (the "Grantor") with principal offices at 1541 South Waukegan Road, Waukegan, Illinois 60085, hereby grants to BANK OF MONTREAL, as Lender, with offices at 105 St-Jacques Street, 3rd Floor, Montreal, Quebec H2Y 1L6 (the "Grantee"), a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.
