Ladies and Gentlemen:

This letter confirms the amount of the Borrowers' indebtedness due to Harris N.A. (the "Bank"), as of January 3, 2010, under that certain Credit Agreement dated as of December 28, 2000, as from time to time amended, (the "Credit Agreement"), between the Borrower and the Bank, all upon the terms and conditions set forth herein.

The total amount of indebtedness, liabilities, and obligations due to the Bank under the Credit Agreements (with the exception of the unused commitment fee), if paid on or before 2:00 p.m. (Chicago, Illinois, time) on January 3, 2011 (the "Payment Time"), is \$1,404,334.56 (the "Pay-off Amount"), broken down as follows:

In the event payment is not made on or before the time and date of the Payment Time, the Pay-off Amount shall be increased by an amount equal to \$68.06 (representing \$68.06 per diem interest on the Term Loan) for each day the Pay-off Amount remains unpaid (the "Per diem Amount"); provided that the Per diem Amount may change in the event of a change in

the Base Rate or in the amount outstanding under the Credit Agreement, and, for these reasons, you should confirm with us on the date of payment the current pay-off amount then due.

Upon receipt of (i) an executed counterpart of this letter from you, and (ii) the Pay-off Amount, (as interest on the same may be increased by \$68.06 each day the Pay-off Amount remains unpaid) Federal reserve wire transfer to

all indebtedness, liabilities, and obligations of the Borrowers to the Bank under the Credit Agreement shall be paid in full, the Borrower shall have no right to obtain credit from the Bank under the Credit Agreement, and the security interest and lien of the Bank in the property of the Borrower, Urban Laboratories International LLC (*Urban Laboratories*"), and Healing Hair Laboratories International LLC (*Healing Hair*") granted to it pursuant to the Credit Agreements shall be automatically released and terminated and the guaranty of Urban Labs and Healing Hair under that certain Guaranty Agreement dated as of December 7, 2009 (and we hereby authorize you or your designee to file UCC termination statements relating to any UCC financing statements currently filed in our favor against any Borrower), and we shall execute and deliver to you such lien release instruments and take such other action as the Borrowers may reasonably request, and at the Borrowers' expense, to release any lien or security interest currently held by the Bank on the property of any Borrower.

Unless otherwise agreed to in writing by us, the terms of this letter shall not be effective after January 5, 2011 unless the conditions set forth in clauses (i)-(ii) above have each been satisfied by such date.
