U.S. INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT  
(Swiss Grantor)

U.S. INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (Swiss Grantor), dated December 17, 2010 ("IP Security Release"), by BANK OF AMERICA, N.A., a national banking association located at 135 South LaSalle Street, Suite 465, Chicago, Illinois 60603, USA, in its capacity as successor collateral agent to Lasalle Business Credit, LLC under a Credit Agreement (ABL) dated as of July 6, 2007, as amended by the First Amendment to Credit Agreement and Agents' Resignation and Appointment, dated September 18, 2008 (together, the "Credit Agreement") (in such capacity, the "Assignor"), in favor of NOVELIS SWITZERLAND SA, a corporation organized under the laws of Switzerland, having its business address at Routes de Laminoirs 15, CH-3960 Sierre, Switzerland ("Assignee").

W I T N E S S E T H:

WHEREAS, Assignee is party to a Security Agreement dated as of July 6, 2007 (the "Security Agreement") in favor of the Assignor, pursuant to which Assignee executed and delivered that certain U.S. Intellectual Property Security Agreement (Swiss Grantors), dated as of July 6, 2007 (the "IP Security Agreement") in order to record the lien and security interest of Assignor in the IP Collateral (as defined in the IP Security Agreement) in the United States Patent and Trademark Office (the "PTO");

WHEREAS, the IP Security Agreement was recorded with the Trademark Division of the PTO on August 24, 2007 at Reel 3608/Frame 0936;

WHEREAS, the secured obligations have been paid and performed in full and any and all other conditions for termination of the IP Security Agreement have been satisfied; and

WHEREAS, Assignor now desires to release its security interest in and to Assignee's right, title and interest in and to the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein but not otherwise defined herein that are defined in the IP Security Agreement shall have the meanings given to them in the IP Security Agreement.

SECTION 2. Release of Security Interest in IP Collateral. Assignor hereby terminates and releases in its entirety its lien on and security interest in the IP Collateral, including the items set forth on Schedule 1 attached hereto.

SECTION 3. Governing Law. This IP Security Release shall be construed in accordance with and governed by the law of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
