SECURITY INTEREST RELEASE

This Security Interest Release is granted on this 6th day of January, 2011, by JPMORGAN CHASE BANK, N.A. 

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby releases, discharges, quitclaims and relinquishes unto the Assignor any and all right, title and interest in and to the Properties, and more particularly, the security interest in the Properties as set forth on Schedule A hereto, granted to the Administrative Agent by the Assignor by the Security Agreements, which, with respect to the Properties consisting of trademarks, was duly recorded on November 22, 2000 in the Trademark Division of the United States Patent and Trademark Office ("USPTO") at Reel/Frame 2183/0838 and which, with respect to the Properties consisting of patents, was duly recorded on July 31, 2003 in the Patent Division of the United States Patent and Trademark Office at Reel/Frame 14289/0742.
