IP SUPPLEMENT NO. 3

This IP SUPPLEMENT NO. 3, dated as of November 30, 2010, is delivered pursuant to and supplements (i) the Trademark Security Agreement, dated as of October 11, 2007 (said Trademark Security Agreement, as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Trademark Security Agreement"), among Levi Strauss & Co., the other Grantors named therein, and Bank of America, N.A., as the Agent for the Lenders; (ii) the Grant of Trademark Security Interest dated as of October 11, 2007 (said Grant of Trademark Security Interest as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Trademark Grant"; the terms defined therein and not otherwise defined herein being used herein as therein defined) executed by Grantor; (iii) the Second Amended and Restated Pledge and Security Agreement, dated as of October 11, 2007, as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Second Amended and Restated Pledge and Security Agreement", among Levi Strauss & Co., the other Grantors named therein, and Bank of America, N.A., as the Agent for the Lenders; and (iv) the Grant of Patent Security Interest, dated as of October 11, 2007, as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Patent Grant"; the terms defined therein and not otherwise defined herein being used herein as therein defined) executed by Grantor.

Grantor grants to the Lenders a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral and the Patent Collateral (the "IP Collateral") set forth on Schedule A and Schedule B attached hereto. All such IP Collateral shall be deemed to be part of the Trademark Collateral and the Patent Collateral and shall be hereafter subject to each of the terms and conditions of the Trademark Security Agreement and the Second Amended and Restated Pledge and Security Agreement and respective Grants.
