TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release of Trademark Security Agreement (this "Release"), dated this 11th day of January, 2011, is by PNC Bank, National Association ("PNC").

A. WHEREAS, FinishMaster Services, Inc., an Indiana corporation ("FinishMaster Services"), granted PNC a security interest in its trademarks listed on Schedule A (collectively the "Trademarks");

B. WHEREAS PNC also recorded its interest in the Trademarks with the United States Patent and Trademark Office (the "USPTO") on March 6, 2006 as Reel/Frame 3259/0088; and

C. WHEREAS FinishMaster Services requests PNC to release any and all right, title, and interest in and to the Trademarks and PNC agrees to release any and all such right, title, and interest.

NOW, THEREFORE, FOR VALUE RECEIVED, PNC agrees as follows:

1) PNC does hereby terminate and release its security interest in and to the Trademarks and all rights therein of any type or description.

2) PNC hereby authorizes FinishMaster Services (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish PNC's rights and interest in the Trademarks.


3) This Release is governed by the law of the State of Indiana, excluding its choice of law principles to the contrary.

4) This Release shall be binding upon PNC and its successors and assigns and inures to the benefit of FinishMaster Services and its successors and assigns.
