This Patent and Trademark Agreement (this "Agreement") is made as of December 23 2010, by and among Citizens Bank of Pennsylvania, as agent for itself and the other Secured Parties (as that term is defined in the Credit Agreement defined below) (together with its successors and assigns in such capacity, "Agent"), and Communications Test Design, Inc., a Pennsylvania corporation (together with its successors and assigns, "Borrower"), and Phoenix Wireless, Inc., a Pennsylvania corporation (together with its successors and assigns, "Restricted Subsidiary Guarantor," and together with Borrower, "Grantors").

WHEREAS, Agent, Borrower, the Lenders (as that term is defined in the Credit Agreement defined below) and certain other parties entered into that certain Credit Agreement dated as of the date hereof (as the same may be amended, restated, modified, supplemented and/or replaced from time to time, the "Credit Agreement"), pursuant to which the Lenders agreed to extend credit to Borrower on the terms and conditions described therein;

WHEREAS, Grantors are obligated to Agent pursuant to a Security Agreement dated as of the date hereof (as the same has been amended, restated, modified, supplemented and/or replaced from time to time, the "Security Agreement") in favor of Agent; and

WHEREAS, pursuant to the Security Agreement, Grantors granted to Agent a security interest in all right, title and interest of Grantors in and to, among other things, the Patents and Trademarks, including the applications and registrations therefor, together with the goodwill of the business connected with the use of and symbolized by the Patents and Trademarks and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations, as defined in the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, each Grantor does hereby grant to Agent a security interest in the Collateral to secure the prompt payment, performance and observance of its obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral made and granted hereby are fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

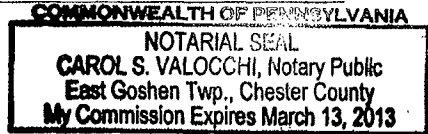

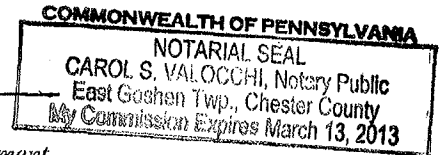
