**RELEASE OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims, and relinquishes unto the Grantor any and all right, title, and interest in and to the Marks (and any proceeds, claims or goodwill associated with, or arising from, the Marks), and more particularly, the security interest in the Marks, granted to the Collateral Agent by the Grantor pursuant to the U.S. Security Agreement, which security interest was duly recorded on July 1, 2008, at Trademark Reel 3806, Frame 0861 in the United States Patent and Trademark Office, and any security interest and any license in such Marks granted to Collateral Agent, to the extent such security interest or license are granted therein, are hereby terminated.
