**RELEASE AND TERMINATION OF
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, THAT, BANK OF AMERICA, N.A., a national banking association and successor by merger to LaSalle Bank National Association (f/k/a LaSalle National Bank), having its principal office located at 135 South LaSalle Street, Mail Code IL-4-135-04-65, Chicago, Illinois 60603 (the "Secured Party"), does hereby release all of its right, title and interest under that certain Trademark Security Agreement dated October 7, 2005 made by EMPIRE TODAY, LLC, a Delaware limited liability company, having its principal office located at 333 Northwest Avenue, Northlake, IL 60164 ("Grantor") in favor of Secured Party, which was recorded with the U.S. Patent and Trademark Office on October 11, 2005 at Reel No. 003179, Frame No. 0456 (the "Trademark Security Agreement"); and Secured Party hereby terminates, releases and discharges all of its right, title and interest in and to (i) the Trademarks (as defined in the Trademark Security Agreement), including, without limitation, those Trademarks set forth in Schedule A attached hereto, in each case together with (ii) all proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising for infringement of any of the Trademarks or unfair competition regarding the same and all damages awarded therefrom.
