RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of October 31, 2006 ("Effective Date") by and among **COLLINS INDUSTRIES, INC.**, a Missouri corporation ("Collins"), **COLLINS BUS CORPORATION**, a Kansas corporation ("Bus"), **WHEELED COACH INDUSTRIES, INC.**, a Florida corporation ("WCI"), **CAPACITY OF TEXAS, INC.**, a Texas corporation ("Capacity"), **MOBILE-TECH CORPORATION**, a Kansas corporation ("Mobile"), **WORLD TRANS, INC.**, a Kansas corporation ("World Trans"), **MID BUS, INC.**, an Ohio corporation ("Mid Bus"), **MOBILE PRODUCTS, INC.**, a Kansas corporation ("Mobile Products", and together with Collins, Bus, WCI, Capacity, Mobile, World Trans and Mid Bus, the "Debtors" and each a "Debtor") and **BANK OF AMERICA, N.A.**, a national banking association and successor in interest to Fleet Capital Corporation ("Secured Party").

WHEREAS, Debtors and Secured Party, as agent and sole lender, are parties to (i) that certain Loan and Security Agreement dated as of May 17, 2003 (the "Loan Agreement") and (ii) that certain Security Agreement (Trademarks) dated as of May 17, 2002 ("Trademark Security Agreement");

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, Debtors granted to Secured Party a security interest in and a lien on the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations and the United States applications for trademark registration set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on June 14, 2002, at Reel 002524, Frame 0692;

WHEREAS, Debtors have paid all of their outstanding indebtedness to Secured Party under the Loan Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

Secured Party shall, at Debtors' expense, take all further reasonable actions, and provide to Debtors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Debtors and reasonably necessary to more fully and effectively effectuate the purposes of this Release.
