## CORRECTIVE RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS

WHEREAS, Nationsbank Of Georgia, N.A. and Nationsbank, N.A., now known as Bank of America, N.A. (hereinafter collectively referred to as “**Bank of America**”), has an address of 101 North Tryon Street, 13<sup>th</sup> Floor, Charlotte, North Carolina 28255; and

WHEREAS, Hoover Group, Inc. and Hoover Materials Handling Group, Inc. (both hereinafter collectively referred to as “**the Hoover Companies**”) have an address of 2135 Highway 6 South, Houston, Texas 77077; and

WHEREAS, Mauser USA, LLC, formerly known as Mauser Corp., formerly known as Mauser USA, Inc. (hereinafter “**Mauser**”), has an address of 2001 Westside Parkway, Alpharetta, Georgia 30004; and

WHEREAS, Hoover Group, Inc. and/or Hoover Materials Handling Group, Inc. owned certain marks as listed in Schedule A hereto (hereinafter the “**Certain Marks**”), and each had previously executed one or more conditional assignments, security interests, or collateral assignments of those Certain Marks in favor of Bank of America; and

WHEREAS, Bank of America executed a Termination of Collateral Assignment (the “**Termination**”) of some of those Certain Marks in favor of Hoover Group, Inc. (but not in favor of Hoover Materials Handling Group, Inc.) dated May 7, 2001, recorded May 30, 2001, at Reel 2311, Frame 0361 of the trademark assignment records of the U.S. Patent & Trademark Office; and

WHEREAS, pursuant to a certain Asset Purchase Agreement by and among the Hoover Companies, Mauser-Hoover Packaging LLC, Mauser USA Inc. and Mauser-Wake GmbH & Co. K.G. dated August 13, 2003 (the “**Purchase Agreement**”), Hoover Group, Inc. (but not Hoover Materials Handling Group, Inc.) executed on August 19, 2003 an Assignment of Entire Interest in favor of Mauser for U.S. Registrations 2330658 for REPALTAINER and 1300160 for BULKDRUM (Stylized) and Japan Registration 2243569 for BULKDRUM (hereinafter collectively referred to as the “**Three Marks**”), recorded on September 5, 2003, at Reel 2818, Frame 0477 of the trademark assignment records of the U.S. Patent & Trademark Office (the “**Prior Assignment**”); and

WHEREAS, notwithstanding the execution, delivery and recording of the Termination and of the Prior Assignment, it was determined by Mauser to be desirable and useful to show clear title as being vested in Mauser for the Three Marks; and

WHEREAS, at the request of Mauser, Bank of America and the Hoover Companies subsequently executed on October 27, 2004 a "Release, Quitclaim, and Assignment of Trademarks" in favor of Mauser, recorded on November 5, 2004 at Reel 2970, Frame 0325 of the trademark assignment records of the U.S. Patent & Trademark Office (listed as a "Nunc Pro Tunc Assignment" on those records); and

WHEREAS, said previous "Release, Quitclaim, and Assignment of Trademarks" was only intended to be for the Three Marks being conveyed to Mauser and was to include a schedule which listed only the Three Marks, but an incorrect schedule (Schedule A hereto) was erroneously attached, and the incorrect schedule listed not only the Three Marks but also listed the rest of the Certain Marks which were owned by the Hoover Companies but which were not intended to be assigned to Mauser, whereby said previous "Release, Quitclaim, and Assignment of Trademarks" erroneously released and assigned all of the Certain Marks to Mauser; and

WHEREAS, in addition, the listing of both Hoover Companies on certain releases of security interests have clouded the title of ownership with respect to whether a mark is owned by jointly or separately by Hoover Group, Inc. or Hoover Materials Handling Group, Inc.;

NOW THEREFORE, in order to correct those errors in said previous "Release, Quitclaim, and Assignment of Trademarks", and to clear the title clouded by said certain releases, the Hoover Companies, Bank of America, and Mauser do hereby execute this CORRECTIVE RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS.

Mauser, Bank of America, and the Hoover Companies hereby agree that said previous Release, Quitclaim, and Assignment of Trademarks was, and is, in error with respect to the Certain Marks (other than the Three Marks) and did not accurately reflect the understanding or intent of the parties with respect to the Certain Marks; and

Bank of America and the Hoover Companies hereby agree that the release of security interests was not intended to jointly convey title to both Hoover Group, Inc. and Hoover Materials Handling Group, Inc. in the Certain Marks; and

The parties hereto agree that this CORRECTIVE RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS is to correct the record of ownership to reflect the intent and understanding of the parties hereto on November 5, 2004; and

Bank of America, Hoover Group, Inc., and Hoover Materials Handling Group, Inc. hereby affirm said previous Release, Quitclaim, and Assignment of Trademarks with respect to the Three Marks mentioned hereinabove; and

Mauser, Bank of America, and Hoover Materials Handling Group, Inc. do hereby release, quitclaim, and assign all right, title and interest in and to the marks listed in Schedule B hereto, including all goodwill and rights of action in respect thereof, to Hoover Group, Inc., this CORRECTIVE RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS being retroactive to, and effective as of, the date of said previous Release, Quitclaim, and Assignment of Trademarks, to the effect of, and as if, such previous "Release, Quitclaim, and Assignment of Trademarks" had never been executed in favor of Mauser with respect to the marks listed in Schedule B and said certain releases had listed only the intended assignee; and

Mauser, Bank of America, and Hoover Group, Inc., do hereby release, quitclaims, and assigns all right, title and interest in and to the marks listed in Schedule C hereto, including all goodwill and rights of action in respect thereof, to Hoover Materials Handling Group, Inc., this CORRECTIVE RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS being retroactive to, and effective as of, the date of said previous Release, Quitclaim, and Assignment of Trademarks, to the effect of, and as if, such previous "Release, Quitclaim, and Assignment of Trademarks" had never been executed in favor of Mauser with respect to the marks listed in Schedule C and said certain releases had listed only the intended assignee.

The undersigned each represents and warrants that s/he has full requisite authority to execute this CORRECTIVE RELEASE, QUITCLAIM, AND ASSIGNMENT OF TRADEMARKS on behalf of the indicated party and to obligate the indicated party to the terms herein.
