BILL OF SALE

THIS BILL OF SALE is executed and delivered pursuant to Section 4.3(b) of the Asset Purchase Agreement (the "Purchase Agreement") between American Builders & Contractors Supply Co., Inc., a Delaware corporation ("Seller") and Great Northern Holding, LLC, a Delaware limited liability company ("Buyer"), dated Feb 4th, 2011.

KNOW ALL MEN BY THESE PRESENTS, that for good and valuable consideration paid by Buyer, the receipt and sufficiency of which are hereby acknowledged by Seller, Seller does hereby transfer, convey and assign to Buyer, its successors and assigns, forever, the "Purchased Assets" as such term is defined in Section 1.1 of the Purchase Agreement, including but not limited to those set forth on Schedules 1.1(a), 1.1(b), 1.1(c), 1.1(d), 1.1(e) and 1.1(h) of the Purchase Agreement and the United States registered trademarks set forth on the attached Exhibit A and the goodwill associated therewith, which are attached hereto and incorporated by reference herein.

TO HAVE AND TO HOLD the Purchased Assets transferred, conveyed and assigned hereinabove unto Buyer, its successors and assigns, and for its and their own use forever. Seller does hereby warrant, covenant and agree that it:

(a) has good and marketable title to the Purchased Assets, subject to such liens and other encumbrances as are disclosed in the Purchase Agreement or any schedules or exhibits thereto and except as otherwise provided in the Purchase Agreement; and

(b) will warrant and defend the sale of said Purchased Assets against all and every person or persons whomsoever claiming or to claim against any or all of the same, subject to the terms and provisions of the Purchase Agreement.

This Bill of Sale shall be governed by and construed in accordance with the laws of the State of Delaware.

All capitalized terms used herein and not otherwise defined herein shall have the respective meanings ascribed thereto in the Purchase Agreement. Nothing in this Bill of Sale shall affect any of the representations and warranties or other terms and provisions in the Purchase Agreement and in the event of any conflict with the Purchase Agreement, the provisions of the Purchase Agreement shall prevail.
