**RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of February 18, 2011, is made by PNC BANK, NATIONAL ASSOCIATION, a national banking association ("Secured Party"), and is as follows:

WHEREAS, Phylogly, Inc., a California corporation ("Debtor"), and Secured Party are parties to that certain Trademark Security Agreement dated as of July 9, 2010 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on August 18, 2010 in its records at Reel 4262, Frame 0649; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;


