RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

WHEREAS, pursuant to that certain Grant of Security Interest In Trademark Rights, dated as of August 3, 2007, recorded in the United States Patent and Trademark Office at Reel 3640, Frame 0027, (the "Trademark Security Agreement"), DaimlerChrysler Financial Services Americas LLC, a Michigan limited liability company ("Releasee"), granted to Wilmington Trust Company, a Delaware corporation ("Releasor"), a continuing security interest in all right, title and interest of Releasee in, to and under the Trademarks (including, without limitation, those items listed on Schedule A hereto) (the "Collateral"), for the benefit of the Second Priority Secured Parties, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Releasee's Second Priority Secured Obligations; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Grant of Security Interest In Trademark Rights, to confirm the release, relinquishment and discharge of its continuing security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty and without any recourse to Releasor, releases, relinquishes and discharges its continuing security interest in the Collateral.

IN WITNESS WHEREOF, the parties have caused this Release of Grant of Security Interest In Trademark Rights to be duly executed as of February 23, 2011.
