**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST dated as of March 3, 2011 (this "**Release**") is made by Credit Suisse AG, as collateral agent (the "**Collateral Agent**") acting for the benefit of the Secured Parties. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

A. Reference is made to the Credit Agreement dated as of December 11, 2009 (as amended, supplemented or otherwise modified through the date hereof, the "**Credit Agreement**"), among Fairway Group Acquisition Company, a Delaware corporation (the "**Borrower**"), Fairway Group Holdings Corp., a Delaware corporation ("**Holdings**"), the Lenders from time to time party thereto, and Credit Suisse AG, as administrative agent and Collateral Agent.

B. Reference is made to the Guarantee and Collateral Agreement dated as of December 11, 2009 (the "**Security Agreement**"), among the Borrower, Holdings, the Subsidiaries of the Borrower from time to time party thereto and the Collateral Agent.

C. Reference is made to the Trademark Security Agreement dated as of December 11, 2009 (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "**Trademark Security Agreement**"), between the Borrower (the "**Trademark Grantor**") and the Collateral Agent, pursuant to which the Trademark Grantor granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, all right, title and interest of the Trademark Grantor in the trademarks, trademark applications and trademark licenses set forth on Schedule I hereto (the "**Released Trademarks**"), which security interest was recorded with the United States Patent & Trademark Office as of December 29, 2009 at Reel/Frame 004122/0105.

WHEREAS, in connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, the Trademark Grantor has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, for the benefit of the Secured Parties and each other grantee or beneficiary, in and to the Released Trademarks granted under the Trademark Security Agreement.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges all right, title and interest (including, without limitation, security interests) of the Collateral Agent in and to the Released Trademarks. The Collateral Agent hereby assigns, transfers and sets over to the Trademark Grantor all right, title and interest that the Collateral Agent has in or to the Released Trademarks under the Security Agreement and the Trademark Security Agreement.

The Collateral Agent agrees to perform all further acts and execute and deliver, at the Borrower's sole expense, all further documents and/or instruments that may be necessary to carry out the provisions of this Release. The execution and delivery of documents or instruments, including this Release, shall be without recourse to, or representation or warranty by, the Collateral Agent.


