*This Security Accession Deed is subject to and has the benefit of an Intercreditor Agreement dated on or about the date hereof and made between, among others, Crown Newco 3 plc as the Parent Senior Secured Notes Issuer and Senior Unsecured Notes Issuer, The Royal Bank of Scotland plc as the RCF Agent, Deutsche Trustee Company Limited as Senior Secured Note Trustee and Senior Unsecured Note Trustee, the financial institutions listed therein as RCF Finance Parties, the financial institutions listed therein as Original Hedge Counterparties, the companies listed therein as Original Intra-Group Lenders, the companies listed therein as Original Intra-Group Borrowers, the persons listed therein as Original Structural Creditors, and Deutsche Bank AG, London Branch as Security Agent, as each term is defined therein*

**THIS SECURITY ACCESSION DEED** is made on 4 March 2011.

**BETWEEN:**

- (1) The companies listed in Schedule 1 to this deed (the “**New Chargors**”); and
- (2) Deutsche Bank AG, London Branch as security trustee for itself and the other Secured Parties (the “**Security Agent**”).

**RECITAL:**

This deed is supplemental to a debenture dated 4 March 2011 between the Parent and the Security Agent (the “**Debenture**”).

**NOW THIS DEED WITNESSES** as follows:

1. **INTERPRETATION**

1.1. **Definitions**

Unless otherwise defined herein, terms defined in the Debenture shall have the same meaning when used in this deed.

“**Thatcham Property**” means the property known as Thornford Park, Crookham, Thatcham, registered at the Land Registry under freehold title numbers BK335895 and BK401651.

1.2. **Construction**

Clauses 1.2 (*Construction*) to 1.5 (*Miscellaneous*) of the Debenture will be deemed to be set out in full in this deed, but as if references in those clauses to the Debenture were references to this deed.

2. **ACCESSION OF NEW CHARGOR**

2.1. **Accession**

Each New Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as a Chargor.

2.2. **Covenant to pay**

Each New Chargor as primary obligor covenants with and undertakes to the Security Agent (for the benefit of itself and the other Secured Parties) that it will on demand pay the Secured Obligations when they fall due for payment.

2.3. **Specific Security**

Each New Chargor, as continuing security for the payment of the Secured Obligations, charges in favour of the Security Agent (to the extent competent under applicable law) with full title guarantee the following assets, both present and future, from time to time owned by it or in which it has an interest subject to Clause 3.5 of the Debenture:

- (a) by way of first legal mortgage:

- (i) subject to Clause 2.6, all Property in England and Wales now belonging to or vested in it (including any property specified in Schedule 1 (*Details of Properties*));
- (b) by way of first equitable mortgage:
  - (i) all the Shares and Investments and all corresponding Related Rights;
- (c) by way of fixed charge:
  - (i) subject to Clause 2.6, all other interests (not charged under Clause 2.3(a)) in any Property in England and Wales now or subsequently belonging to it;
  - (ii) all of its rights, title and interest in the Intellectual Property;
  - (iii) all its Trading Receivables and all its rights and claims against third parties and against any security in respect of those Trading Receivables;
  - (iv) all its Other Debts and its all rights against third parties in respect of such Other Debts;
  - (v) all monies standing to the credit of the Blocked Accounts;
  - (vi) all rights and interest in the Hedging Agreements;
  - (vii) the benefit of all consents and agreements held by it in connection with the use of any of its assets;
  - (viii) its goodwill and uncalled capital; and
  - (ix) subject to clause 3.5 of the Debenture, if not effectively assigned by Clause 2.5 (Security Assignment), all its rights and interests in (and claims under) the Insurance Policies (other than those maintained for the benefit of a person which is not the Parent of any Subsidiary of the Parent) and the Assigned Agreements.

**2.4. Floating charge**

As further security for the payment of the Secured Obligations, each New Chargor charges with full title guarantee in favour of the Security Agent (for the benefit of itself and the other Secured Parties) by way of first floating charge all its present and future assets and rights not effectively charged by way of fixed charge under Clause 2.3 (*Specific Security*) or assigned under Clause 2.5 (*Security Assignment*).

**2.5. Security Assignment**

As further security for the payment of the Secured Obligations, each New Chargor assigns absolutely (to the extent competent under applicable law) with full title guarantee to the Security Agent all its rights, title and interest in:

- (a) the Hedging Agreements;
- (b) the Insurance Policies; and
- (c) the Assigned Agreements,

(subject in each case to reassignment by the Security Agent to the new Chargor of all such rights, title and interest upon payment or discharge in full of the Secured Obligations). To the extent that any Hedging Agreement, Insurance Policy or Assigned Agreement described in Clause 2.5 is not assignable, the assignment which that clause purports to effect shall operate as an assignment of all present and future rights and claims of such Chargor to any proceeds of such Hedging Agreement, Insurance Policy or Assigned Agreement.

**2.6. Thatcham Property**

- (a) In respect of Priory Finance Property LLP and Priory Secure Services Limited, Clause 2.3(a)(i) and Clause 2.3(c)(i) shall not apply to the Thatcham Property.
- (b) With effect from 6 March 2011, Priory Finance Property LLP and Priory Secure Services Limited shall charge:
  - (i) by way of first legal mortgage in favour of the Security Agent the Thatcham Property on the same terms as Clause 2.3(a)(i); and
  - (ii) to the extent not effectively charged by way of first legal mortgage, by way of fixed charge in favour of the Security Agent all other interests in the Thatcham Property on the same terms as Clause 2.3(c)(i).
- (c) Priory Finance Property LLP and Priory Secure Services Limited will deliver to the Security Agent on the date of this deed a fully executed supplemental legal mortgage in respect of the Thatcham Property, which will be held in escrow by the Security Agent and automatically released and dated on 6 March 2011.

**3. CONSENT OF EXISTING CHARGORS**

The Parent on behalf of the existing Chargors agrees to the terms of this deed and agrees that its execution will in no way prejudice or affect the security granted by each of them under (and covenants and undertakings given by each of them in) the Debenture.

**4. CONSTRUCTION OF DEBENTURE**

The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to "this deed" or "this Debenture" will be deemed to include this deed.

**5. NOTICES**

Each New Chargor confirms that its address details for notices in relation to Clause 23 (*Notices*) of the Debenture are as set out next to its execution block of this deed.

**6. COUNTERPARTS**

This deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this deed.

**7. GOVERNING LAW**

This deed (and any dispute, controversy, proceedings or claims of whatever nature arising out of or in any way relating to this deed or its formation) and obligations of the Parties hereto and any matter, claim or dispute arising out of or in connection with this deed (including any non-contractual claims arising out of or in association with it) shall be governed by and construed in accordance with English law.




