**RELEASE OF SECURITY INTEREST**

**THIS RELEASE** is given by National Bank of Canada, a bank governed by the Bank Act (Canada) (the "**Secured Party**") to ServerBeach, Ltd., a Texas corporation, having its principal office at 555 West Hastings Street, Suite 1000, Vancouver, Canada V6B 4N5 (the "**Debtor**").

**WHEREAS** the Debtor entered into a Credit Agreement made as of May 29, 2009 (the "**Credit Agreement**") in favour of the Secured Party granting a security interest in certain intellectual property of the Debtor described in the attached Schedule A (the "**US IP**");

**WHEREAS** the Debtor entered into a Grant of Security Interest in United States Trademarks made as of June 24, 2009 (the "**Trade-mark Security Agreement**") in favour of the Secured Party as collateral agent for certain lenders;

**WHEREAS** the Trade-mark Security Agreement was recorded with the United States Patent and Trade-mark Office on July 1, 2009 against the US IP.


**NOW THEREFORE**, the Secured Party hereby: (i) irrevocably releases, remises and forever discharges the US IP from any encumbrances constituted by the Trade-mark Security Agreement or the Credit Agreement and (ii) undertakes to deliver, upon the request and at the sole expense of the Debtor, all discharges, releases and other documents as may be prepared by or on behalf of the Debtor and provided to the Secured Party and as are reasonably necessary to give effect to the releases, remises and discharges granted by the Secured Party pursuant to this Release of Security Interest.
