**TERMINATION AND RELEASE
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE dated as of March 18, 2011, from **General Electric Capital Corporation** (“GECC”), in its capacity as collateral agent (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”) for the Secured Parties (as defined in that certain First Lien Pledge and Security Agreement, dated as of June 29, 2005 (as amended, supplemented, replaced or otherwise modified from time to time, the “Pledge and Security Agreement”)) to **Euramax International, Inc.**, a Delaware corporation (“Company”); **Amerimax Building Products, Inc.**, a Delaware corporation; **Amerimax Diversified Products, Inc.**, a Delaware corporation; **Amerimax Fabricated Products, Inc.**, a Delaware corporation; **Amerimax Finance Company, Inc.**, a Delaware corporation; **Amerimax Home Products, Inc.**, a Delaware corporation; **Amerimax Richmond Company**, an Indiana corporation; **Fabral Holdings, Inc.**, a Delaware corporation; **Fabral, Inc.**, a Delaware corporation; **AMP Commercial, Inc.** (successor-in-interest to Gutter Acquisition, Inc. and Gutter Suppliers, Inc.) a Delaware corporation; **Berger Building Products, Inc.** a Pennsylvania corporation; **Berger Holdings, Ltd.**, a Pennsylvania corporation; **Amerimax UK, Inc.**, a Delaware corporation; **Euramax International Holdings Limited**, a United Kingdom private limited company; **Euramax Holdings Limited**, a United Kingdom private limited company; **Amerimax Finance Products, Inc.**, a Delaware corporation; **Euramax Coated Products B.V.**, a Dutch private company with limited liability; **Euramax European Holdings B.V.**, a Dutch private company with limited liability; **Euramax Canada Holdings, Inc.**, an Ontario, Canada corporation; and **Euramax Canada, Inc.**, an Ontario, Canada corporation (each a “Grantor” and collectively the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to the Pledge and Security Agreement and the Intellectual Property Security Agreement dated as of June 29, 2005, in favor of Collateral Agent (the “IP Security Agreement”), a security interest (the “Security Interest”) was granted by the Grantors to Collateral Agent in the Intellectual Property Collateral (as defined in the IP Security Agreement);

WHEREAS, the IP Security Agreement was recorded against the Patents (as defined in the IP Security Agreement) listed on Schedule 1 of the IP Security Agreement with the Assignment Division of the United States Patent and Trademark Office at Reel 016360, Frame 0846 on August 8, 2005; at Reel 016360, Frame 0861 on August 8, 2005; at Reel 016360, Frame 0876 on August 8, 2005; at Reel 016360, Frame 0925 on August 8, 2005; and at Reel 016360, Frame 0940 on August 8, 2005;

WHEREAS, the IP Security Agreement was recorded against the Trademarks (as defined in the IP Security Agreement) listed on Schedule 1 of the IP Security Agreement with the Assignment Division of the United States Patent and Trademark Office at Reel 3137, Frame 0063 on August 8, 2005; at Reel 3137, Frame 0078 on August 8, 2005; at Reel 3137, Frame 0093 on August 8, 2005; at Reel 3137, Frame 0189 on August 8, 2005; at Reel 3137, Frame 0001 on August 8, 2005; at Reel 3137, Frame 0016 on August 8, 2005; and at Reel 3137, Frame 0031 on August 8, 2005;

WHEREAS, the IP Security Agreement was recorded against the Trademarks (as defined in the IP Security Agreement) from Canada listed on Schedule 1 of the IP Security Agreement with the Canadian Intellectual Property Office at File No. 354388 on March 21, 2007 and at File No. 1394671 on April 14, 2009;

WHEREAS, pursuant to the Pledge and Security Agreement and the First Supplement to the Intellectual Property Security Agreement, dated as of April 30, 2009, in favor of Collateral Agent (the "First Supplement"), a continuance of the Security Interest was granted by Grantors to Collateral Agent in the Intellectual Property Collateral (as defined in the First Supplement);

WHEREAS, the First Supplement was recorded against the Patents (as defined in the First Supplement) listed on Schedule 1 of the First Supplement with the Assignment Division of the United States Patent and Trademark Office at Reel 022659, Frame 0468 on May 11, 2009;

WHEREAS, the First Supplement was recorded against the Trademarks (as defined in the First Supplement) listed on Schedule 1 of the First Supplement with the Assignment Division of the United States Patent and Trademark Office at Reel 003984, Frame 0915 on May 11, 2009;

WHEREAS, pursuant to the Pledge and Security Agreement and the Second Supplement to the Intellectual Property Security Agreement dated as of June 7, 2010, in favor of Collateral Agent (the "Second Supplement") a continuance of the Security Interest was granted by Grantors to Collateral Agent in the Intellectual Property Collateral (as defined in the Second Supplement);

WHEREAS, the Second Supplement was recorded against the Patents (as defined in the Second Supplement) listed on Schedule 1 of the Second Supplement with the Assignment Division of the United States Patent and Trademark Office at Reel 024826, Frame 0020 on August 11, 2010;

WHEREAS, the Second Supplement was recorded against the Trademarks (as defined in the Second Supplement) from Canada listed on Schedule 1 of the Second Supplement with the Canadian Intellectual Property Office at File No. 1370317 on August 23, 2010; and

WHEREAS, GECC now desires to terminate and release the entirety of its Security Interest in the Intellectual Property Collateral as defined in, and granted to GECC under, the Pledge and Security Agreement, the IP Security Agreement, the First Supplement, and the Second Supplement.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property Collateral pursuant to the Pledge and Security Agreement, the IP Security Agreement, the First Supplement, and the Second Supplement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, GECC hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the First Lien Credit and Guaranty Agreement dated as of June 29,

2005 (the "Credit Agreement"), the Pledge and Security Agreement, the IP Security Agreement, the First Supplement and the Second Supplement.

2. Release of Security Interest. GECC hereby terminates, releases, and discharges its Security Interest in the Intellectual Property Collateral as defined in, and granted to GECC under, the Pledge and Security Agreement, the IP Security Agreement, the First Supplement and the Second Supplement, including the intellectual property collateral listed in Schedule 1 attached hereto. Any and all right, title, or interest of GECC in such Intellectual Property Collateral and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Intellectual Property Collateral and any and all causes of action which may exist by reason of infringement of the Intellectual Property Collateral, shall hereby cease and become void.

3. Further Assurances. GECC hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Intellectual Property Collateral contemplated hereby.
