RELEASE OF TRADEMARKS AND LETTERS PATENT SECURITY AGREEMENT


This agreement dated Feb. 17, 2011, is by and between Steinway, Inc. ("Steinway") and Bank of America Corporation ("Bank of America"), successor in interest to Fleet National Bank ("Fleet"), individually and as agent for Bayerische Hypotheken-Und Wechsel Bank ("Hypo"). For good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties hereby agree as follows:

Steinway and Fleet are parties to a Trademarks and Letters Patent Security Agreement dated August 15, 1990, and recorded in the US Patent and Trademark Office at Reel/Frame 0742/0509.

Bank of America, as successor in interest to Fleet, hereby relinquishes to Steinway the continuing security interest in and lien on the Trademarks as referenced in Exhibit A hereto and otherwise assigns, grants and conveys to Steinway any and all rights Bank of America may have in or to the Trademarks in order to revest in Steinway full and unencumbered title to the Trademarks.
