NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee all rights, title, and interest in and to the Intellectual Property, together with any goodwill of the business connected with the use of and symbolized by the Intellectual Property and the right to prosecute and recover monetary damages for past, present and future infringements or other violations of the Intellectual Property solely to the extent Assignor holds or has the right to transfer any right, title or interest in and to the Intellectual Property, as of the date hereof.




