**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS ("Termination") is executed and delivered as of 31st day of March, 2011 by PNC Bank, National Association, a national banking association (the "Secured Party") to Integrated Solutions, LLC, a Delaware limited liability company ("Integrated Solutions"), and Presidio, Inc., a Georgia corporation ("Presidio").

**BACKGROUND**

A. On December 16, 2010, each of Integrated Solutions and Presidio executed and delivered to the Secured Party a Patent and Trademark Security Agreement (the "Security Agreement").

B. Pursuant to the Security Agreement, each of Integrated Solutions and Presidio granted to the Secured Party a security interest in certain patents and trademarks, including, without limitation, the trademarks set forth on Schedule II attached hereto and made a part hereof (the "Security Interest").

C. The Security Interest was recorded in the United States Patent and Trademark Office ("USPTO") at Reel/Frame 4439/0452.

D. In consideration of the satisfaction of the obligations secured by the Security Interest, the Secured Party desires to release such Security Interest;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. In consideration of the satisfaction of the obligations secured by the Security Interest and to the extent the Secured Party was granted any of the following rights, title and interest under the Security Agreement, the Secured Party hereby terminates and releases all of its rights, title and interest in, to and under any and all of the following assets and properties now owned or at any time hereafter acquired by each of Integrated Solutions and Presidio or in which each of Integrated Solutions and Presidio now has or at any time hereafter may acquire any right, title or interest, including all of the Secured Party's lien and Security Interest as provided for in the Security Agreement in all of the following (in each case, however, only to the extent the Secured Party was granted any such rights, title and interest under the Security Agreement):

(a) all letters patent of the United States, all registrations and recordings thereof, and all applications for letters patent of the United States, including, without limitation, registrations, recordings and pending applications in the United States Patent and Trademark Office, as listed on Schedule I;

(b) all reissues, continuations, divisions, continuations-in-part, renewals or extensions thereof, and the inventions disclosed or claimed therein, including, without limitation, the right to make, use and/or sell the inventions disclosed or claimed therein;

(c) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including, without limitation, registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States, and all extensions or renewals thereof, including, without limitation, the trademarks and patents as listed on Schedule II;

(d) all goodwill associated therewith or symbolized thereby; and

(e) all other assets, rights and interests that uniquely reflect or embody such goodwill.

2. Each of Integrated Solutions and Presidio, or their respective designees, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intention of this Termination.



All of the foregoing shall be at the sole expense of Integrated Solutions and Presidio, with no liability to the Secured Party or any Lender, and with no representation or warranty of any kind, express or implied, by or recourse to the Secured Party or any Lender.
