WHEREAS, Hines Nurseries LLC is the owner of record of the Trademarks at the United States Patent and Trademark Office; and

WHEREAS, Assignee wishes to acquire all of Hines Nurseries LLC's right, title and interest in and to the Trademarks and all of Consolidated Horticulture Group, LLC's and New Hines Parent Company LLC's right, title and interest, if any, in and to the Trademarks, if any, and Assignors wish to assign same to Assignee.






