**RELEASE OF SECURITY INTEREST  
(Trademarks)**

This RELEASE, dated as of April 7, 2011, is made by BARCLAYS BANK PLC (“Barclays”), a company registered in England (registered number 1026167), whose registered office is at 1 Churchill Place, London E14 5HP, as Collateral Agent, in favor of WESCO AIRCRAFT HARDWARE CORP. (“Wesco”), a California corporation, located at 27727 Avenue Scott, Valencia, California 91335 as follows:

**WHEREAS**, pursuant to the Credit Agreement, dated as of September 29, 2006 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), Wesco granted a security interest in the trademarks (hereinafter “the Marks”) listed in the attached Exhibit A, which security interest was recorded in the United States Patent and Trademark Office on October 3, 2006 at Reel/Frame No. 003401/0408 and which security interest is now held by Barclays pursuant to the Amendment, Resignation, Waiver, Consent and Appointment Agreement, dated January 31, 2011 and was recorded in the United States Patent and Trademark Office on February 1, 2011 at Reel/Frame No. 004465/0037. Defined terms in the Credit Agreement have the same meanings where used herein, unless otherwise defined.

**WHEREAS**, Wesco has requested that Barclays release its security interest in all right, title, and interest of Barclays in and to the Marks, and all licenses, royalties, and other monies relating thereto, including goodwill, set forth in Exhibit A.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Barclays hereby releases any security interest previously granted in the Collateral granted under the Credit Agreement including, but not limited to, the security interest in the Marks and terminates all of its right, title and interest in, to, and under the Marks and any and all liens and encumbrances.
