RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST made and entered into this 14th day of November, 2006, by HARRIS N.A., as successor by merger to Harris Trust and Savings Bank, an Illinois banking corporation ("Assignor"), as agent for Secured Creditors as defined in the Security Agreement referenced below, in favor of RENT-WAY, INC., a Pennsylvania corporation ("Assignee").

WHEREAS, Assignor and Assignee are parties to a certain Security Agreement dated as of June 2, 2003 (the "Security Agreement") pursuant to which the parties executed a certain Trademark Collateral Agreement dated June 3, 2003 (the "Collateral Agreement"), and recorded in the United States Patent and Trademark Office on June 9, 2003 at Reel 002748, Frame 0441 under which Assignee granted Assignor a security interest in certain property described in the Security Agreement and the Collateral Agreement, including but not limited to the trademarks and registrations listed in Schedule I attached hereto; and

WHEREAS, Assignor now desires to release and terminate the Security Agreement and the Collateral Agreement;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases to Assignee all interest which Assignor and/or the Secured Creditors possess are otherwise entitled to in the aforementioned property, including but not limited to the trademarks and registrations listed in Schedule I hereto, by virtue of such Collateral Agreement or Security Agreement.
