SUPPLEMENTAL INTELLECTUAL PROPERTY COLLATERAL AGREEMENT

This 11th day of April, 2011, FITNESS QUEST INC., a Delaware corporation ("Debtor") with its principal place of business and mailing address at 1400 Raff Road S.W., Canton, Ohio 44710, in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, mortgages and pledges to Comerica Bank ("Comerica"), with its mailing address at One Detroit Center, Detroit, Michigan 48226, acting as administrative agent hereunder for the Secured Creditors as defined in that certain Security Agreement hereinafter defined (Comerica acting as such administrative agent and any successor or successors to Comerica acting in such capacity being hereinafter referred to as the "Agent") and grants to the Agent for the benefit of the Secured Creditors, a continuing security interest in, the following property (collectively, the "IP Collateral"):

1. Each (i) patent and patent application and all of the inventions described and claimed therein and any and all reissues, continuations, continuations-in-part or extensions thereof, (ii) copyright, copyright registration and copyright application and all of the works of authorship described and claimed therein and any and all renewals, derivative works, enhancements, modifications, new releases and other revisions thereof and (iii) each trademark, trademark registration and trademark application and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application, in each case as listed on Schedule A-1 hereto; and

2. Each (i) patent license and all royalties and other sums due or to become due under or in respect of each such patent license, together with the right to sue for and collect all such royalties and other sums, (ii) each copyright license and all royalties and other sums due or to become due under or in respect of each such copyright license, together with the right to sue for and collect all such royalties and other sums and (iii) each trademark license and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums, in each case as listed on Schedule A-2 hereto; and

3. All proceeds of the foregoing, including without limitation (i) any claim by Debtor against third parties for damages by reason of past, present or future infringement of any patent listed on Schedule A-1 hereto or of any patent licensed under a patent license listed on Schedule A-2 hereto, in each case together with the right to sue for and collect said damages, (ii) any claim by Debtor against third parties for damages by reason of past, present or future infringement of any copyright listed on Schedule A-1 hereto or of any copyright licensed under a copyright license listed on Schedule A-2 hereto, in each case together with the right to sue for and collect said damages; and (iii) any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or

trademark license, in each case together with the right to sue for and collect said damages;

to secure performance of all Secured Obligations (as such term is defined in the Security Agreement defined below) of the Debtor and the other debtors as set out in that certain Security Agreement dated as of October 20, 2004 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and among the Debtor, the other debtors party thereto, and the Agent (executed by its predecessor as Agent, Harris Trust and Savings Bank).

The Debtor and the Agent acknowledge and agree that this Agreement grants a security interest over the IP Collateral as described herein but does not amend, restate or otherwise replace that certain Amended and Restated Trademark Collateral Agreement dated as of July 31, 2006 by and among Debtor and Agent, that certain Amended and Restated Patent Collateral Agreement dated as of July 31, 2006, that certain Amended and Restated Copyright Collateral Agreement dated as of July 31, 2006 and that certain Supplemental Intellectual Property Collateral Agreement dated as of July 13, 2009 (the "Original IP Agreements"). Each of the Original IP Agreements remains in effect and the Debtor hereby reaffirms each of the terms, covenants and agreements set forth in the Original IP Agreements.


As permitted by Section 12.11 of the Credit Agreement, and as promptly as practicable following receipt of notice from the Debtor of the sale, disposal, termination or expiration of any of the IP Collateral set forth on Schedule A-1 or Schedule A-2 hereto, the Agent shall execute a release of security interest such IP Collateral, in form and substance reasonably satisfactory to the Debtor, through which the Agent releases its security interest in such IP Collateral and the Agent shall file such release of security interest in patents with the United States Patent and Trademark Office or United States Copyright Office, as applicable. Promptly following the filing of such release of security interest in such IP Collateral, and receipt by the Agent of, as applicable, (a) the official notice of recordation from the United States Patent and Trademark Office (evidencing receipt and recordation of the release of security interest in such IP Collateral and referencing the recordation date and reel/frame number of the recordation) or (b) a copy of the document recordation cover sheet as filed with the United States Copyright Office evidencing filing of the release of security interest in the applicable IP Collateral, together with a copy of all correspondence from the United States Copyright Office evidencing recordation of the release of the security interests in such IP Collateral (collectively, the "Release Documents"), the Agent shall provide copies of the Release Documents to Debtor.

Debtor does hereby further acknowledge and affirm the rights and remedies of Agent with respect to the mortgage, pledge and security interest in the IP Collateral made and granted hereby include all the rights and remedies set forth in the Security Agreement and any related loan document, including but not limited to the remedies set forth in Section 10 of the Security Agreement, in its entirety.


All terms defined in the Security Agreement, whether by reference or otherwise, when used herein, shall have their respective meanings set forth therein, unless the context requires otherwise.
