**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**


WHEREAS **The Sheridan Group Holding Company**, a Delaware corporation with an address at 1105 North Market Street, Suite 1300, Wilmington, Delaware 19801, **The Sheridan Press, Inc.**, a Maryland corporation with an address at 450 Fame Avenue, Hanover, Pennsylvania 17331, **Capital City Press, Inc.**, a Vermont corporation with addresses at 2178 Airport Road, Barre, Vermont 05641 and 5 Pilgrim Park Road, Suite 5, Waterbury, Vermont 05676, **Sheridan Books, Inc.**, a Delaware corporation with an address at 613 East Industrial Drive, Chelsea, Michigan 48118, **Dartmouth Printing Company**, a New Hampshire corporation with an address at 69 Lyme Road, Hanover, New Hampshire 03755, **Dartmouth Journal Services**, a New Hampshire corporation with an address at 5 Pilgrim Park Road, Suite 5, Waterbury, Vermont 05676, **United Litho, Inc.**, a Maryland corporation with an address at 21800 Beaumeade Circle, Ashburn, Virginia 20147, and **The Sheridan Group, Inc.**, a Maryland corporation with an address at 11311 McCormick Road, Suite 260, Hunt Valley, Maryland 21031 (together, the "Grantors"), entered into that certain security agreement dated August 21, 2003 (the "Security Agreement") with **The Bank of New York Mellon**, formerly known as **The Bank of New York**, a New York banking corporation ("BNYM"), notice of which was recorded August 27, 2003 at the United States Patent and Trademark Office at Reel 2708, Frame 0237.

WHEREAS, Grantors granted BNYM, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of BNYM, in and to certain of Grantors' intellectual property, including without limitation the trademarks listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, BNYM has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, BNYM, for itself and on behalf of the lenders in association with the Security Interest, hereby releases all liens and the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantors and its successors and assigns in association with the Security Interest, and hereby releases Grantors and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
