W I T N E S S E T H:

WHEREAS, the Grantor has heretofore granted to the Grantee a continuing security interest in, to and under certain United States trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Obligations of the Grantor (as such term is defined in the Security Agreement among the Grantor, the other assignors from time to time party thereto and the Grantee, dated as of November 10, 2005 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement")); and

WHEREAS, the Grantee wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all Liens and encumbrances respecting the Marks shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby, without recourse and without representation or warranty of any kind (either express or implied), releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in, to and under the Marks, and more particularly, (i) the continuing security interest in the trademarks, trademark registrations and trademark

applications as set forth on Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action prior to or after November 10, 2005 for infringement of any of the Marks or unfair competition regarding the same, and granted to the Grantee by the Grantor by the Security Agreement which was duly recorded on December 16, 2005 at Trademark Reel 3212, Frame 0181 in the United States Patent and Trademark Office.
