TRADEMARK SECURITY RELEASE

This Trademark Security Release (this "**Release**") is made and entered into as of this 4th day of April 2011 by and among The Bank of New York Mellon, as administrative agent for the Secured Parties (in such capacity, the "**Administrative Agent**"), in favor of the entities listed on Exhibit A (the "**Grantors**"). All capitalized terms used but not defined herein have the meanings set forth in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, all of the Grantors and the Administrative Agent are party to that certain Pledge and Security Agreement, dated as of October 6, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**") and that certain Trademark Security Agreement entered into in connection therewith, dated as of November 6, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Trademark Security Agreement**");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantors granted to the Administrative Agent, a lien on and security interest in, the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 13, 2009 at reel 4095, frame 0959; and

NOW THEREFORE, in consideration of the foregoing, the Administrative Agent, intending to be legally bound, agrees as follows:

1. The Administrative Agent does hereby (i) terminate the Trademark Security Agreement, and (ii) absolutely, unconditionally and irrevocably terminate, cancel, release and forever discharge and convey to the Grantors, their successors, assigns and other legal representatives, without representation or warranty of any kind, all of the Administrative Agent's or its predecessors, successors and assigns right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A attached hereto.
2. The Administrative Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
3. All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the Administrative Agent and the Grantors.

4. The Administrative Agent shall take all further actions, and provide to each Grantor, its successors, assigns and other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments in form and substance reasonably satisfactory to the Administrative Agent), at the sole cost and expense of the Grantors, reasonably requested by any Grantor to more fully effectuate the purposes of this Release.
5. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
