## NOTICE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS is made the 20th day of April, 2011 by and between ASSOCIATED BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, and any successor in such capacity, the "Administrative Agent") for the benefit of the Lender Parties (as defined in the Credit Agreement referenced below), and ALTA RESOURCES CORP., a Wisconsin corporation ("Resources").

Resources and the Administrative Agent acknowledge the following:

A. Pursuant to a Credit Agreement dated as of the date hereof (as amended, restated or otherwise modified from time to time, the "Credit Agreement"; capitalized terms not otherwise defined herein have the meaning assigned to such terms in the Credit Agreement) by and among Resources, Alta Enterprises, LLC, a Wisconsin limited liability company ("Enterprises" and together with Resources, each a "Borrower" and collectively, the "Borrowers"), various financial institutions (the "Lenders") and Associated Bank, National Association, as agent for the Lenders, the Lenders have agreed to make loans and provide financial accommodations to the Borrowers on the terms and conditions set forth therein.

B. To secure the Obligations, the Borrowers have granted to the Administrative Agent for the benefit of the Lender Parties a security interest in substantially all of their assets pursuant to the terms and conditions of a Security Agreement dated as of the date hereof (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and among the Loan Parties and the Administrative Agent.

C. Resources owns the trademark listed on Exhibit A attached hereto (the "Trademark"), which Trademark has been granted by the United States Patent and Trademark Office.

D. Pursuant to the Security Agreement, Resources has granted to the Administrative Agent for the benefit of the Lender Parties, a security interest in and to the Trademark and to all proceeds and benefits thereof.
